Town Meeting is **Saturday, March 3rd 1:00 at the Community Center**. Public questions and highway and general budgets will be voted from the floor. You have to be there to vote!

Officers will be chosen on **Tuesday, March 6th** via Australian balloting at the Community Center. You may cast an early/absentee ballot for that election.

There is only one contested race this year, **Eric Buffum** and **Laurie Phillips** are both running for road commissioner.

The Mill River Unified Union School District voting for the school budget and other fiscal matters, including a bond for construction will be on Tuesday, March 6^{th} from 8:00 am - 7:00 pm at the Community Center.

~ Town Meeting Lunch ~

Tinmouth Elementary School Grades 5 & 6 will be providing lunch and baked goodies. Come early to grab a bite before Town Meeting starts! They will also have a bake sale on Election Day, Tuesday March 6th.

~ Registering to Vote ~

You do not have to register to vote before the election (the deadline used to be five days before). Vermont has instituted **same-day voter registration**, meaning that if you have not previously registered to vote and want to do so on town meeting day, you can register then and there.

You do need to be a resident of the town in which you are registering to vote, and proof of that (like a utility bill).

~ Absentee Ballots ~

If you wish to request an **Absentee Ballot**, you must do so before **5:00 pm** on **Monday**, **March 5th**. **Voted ballots must be returned by 7:00 pm on Tuesday**, **March 6th**. You can also vote **early** at the town office until 5:00 on March 5th.

~ Homestead Declaration ~

This a reminder that you need to file an **annual** Homestead Declaration with the Vermont Department of Taxes, form HS-122. You must file this to qualify for the homestead education tax rate and to request a property tax adjustment if you are eligible. You must also file form HI-144 (household income), **due April 17**th. This is required even if you do not have to file or pay state income taxes.

~ Free Tax Assistance ~

BROC Community Action is again offering free tax assistance as a VITA (Volunteer Income Tax Assistance) site. With the help of volunteers from Castleton University's accounting program, they are ready to make you an appointment to have your taxes prepared. If you make \$54,000 or less, are a person with a disability, or are elderly, the volunteers and staff can prepare and file Federal income tax returns, Vermont State income tax returns, homestead declarations and property tax adjustment claims, household income schedules and renter rebate claims.

The Internal Revenue Service (IRS) sponsors the VITA program and all volunteers and staff receive training from the IRS and the Vermont Department of Taxes.

Dear Friends,

In the Christian tradition, Lent mirrors Jesus' time spent in the desert fasting, praying, dealing with temptation and discerning what his ministry might entail. Many Christians give up some habit as an act of devotion for Lent, spending the freed up time in prayer, meditation and fasting. Ash Wednesday, the first day

of Lent, fell on Valentine's Day this year, and so we contemplated how love relates the Lenten season and its time of letting go. We talked about opening our hearts to God and to Love with a capital "L". This love goes beyond what individuals are capable of, a deeper love that requires *all* of us to bring it into reality.

We talked about opening our hearts in vulnerability and in a desire to make the world we live in a better place for all. One of the questions we reflected on was, "What makes your heart break?" And then, instead of giving something up for Lent, each of us chose something we would take on for Lent, a prayer focus or a task that related to this breaking of our hearts.

Driving home from the service, we heard about the shooting at a school in Parkland, Florida; and my heart broke even more. There have been 18 school shootings this year alone, and hearts all over this nation are breaking, grieving the pointless loss of life. Maybe your heart is breaking too? Our hearts are breaking with the despair, loneliness and anger that are way too present in the lives of too many of our young people in this nation.

In response to all of this, we need to pray, of course, for the victims and their families, but we also need to pray for this nation of ours. We need to send loving and healing thoughts in whatever way we do those sorts of things, to all of the people who need support and care. But we also need to give of ourselves to the young and to the vulnerable people in our midst. We need to invest in them and in their lives. We need to show interest in their thoughts and ideas, their hopes and fears. We also need to speak up alongside them, to let those in leadership know that we will not accept living with such devastating violence. We need to stand with the youth who are speaking truth to power as they march on Washington, as they tell our leaders that the time for responsible gun control is way overdue.

We cannot afford to let our hearts keep breaking like this, over and over. We cannot afford to lose any more beautiful young lives. Every life is precious, every single one. This Lenten season, my prayer is that we will all look deep into our hearts to see what we can do to bring Love with a capital "L" back into our communities, into our nation and into the world. Lent ends on Easter, which this

year Easter falls on April 1st – April Fool's Day – wouldn't it be wonderful to put our past foolishness aside, to have reason to laugh and celebrate together?

My sister and I moved away when we were in the fourth grade to Middlebury, where my father was transferred. The fourth grade there had forty children. Us poor little farm girls didn't know what to think. We made it though, but I never liked the city, I'm a country girl.

I have lived in a few different places but here in Tinmouth is the best. I also have traveled most of the United States but here is where I want to stay.

~Meeting Highlights~

Select Board ~ 2/8/18

Present were members Cathy Reynolds, Frank Sears, and Matt Patry, as well as Eric Buffum – Road Commissioner, Michael Fallar, Heather McMahon, Kim Harbaugh, Sherry Johnson, Grant Reynolds, Jo Reynolds, Jeff Delurey (Delurey Sales & Service Inc.) and Gail Fallar.

Board discussed truck bid process. Frank raised concerns about the legality of the bid opening on January 25th, and the information gathered following. One of the bids was sent via email, and thus was not a sealed bid. Much discussion about the process, how to proceed, whether to start over and re-bid whether to re-bid the truck and equipment as one unit.

In the end, Matt moved to reject the emailed truck bid (for not following bid specs requiring a sealed bid), Frank 2nded, Matt and Frank voted yes, Cathy voted no. Motion passed.

Board then moved to choose from the original three bidders who complied with the specs, Frank 2nded, Matt and Frank voted yes, Cathy voted no. Motion passed.

Matt moved to purchase the 2019 HV513 International Truck as bid by Delurey Sales & Service, Inc., for \$122,375 (\$72,375 net with trade-in of \$50,000), Jeff Delurey advised he will work with Eric to add new features that are now needed.

Bob then opened bids for Equipment for the truck, dump body, plow, wing, etc.. HP Fairfield bid \$75,999; Tenco Industries Inc bid \$58,949 (didn't include auto chains or different tail gate); Viking Cives (USA) bid \$64,550. After brief discussion, Board voted to accept the Viking bid including the options for a total of \$67,400. In other highway business, Eric noted it just keeps snowing, salt is running low – company in Rutland is waiting for more to arrive by train. Board thanked Eric and Ronnie for their hard work this winter, it's been a stormy one.

Board discussed the Master Plan for the town garage/transfer station. Cathy proposed sending out a request for qualifications (RFQ) for a design build. This would hire a firm to work with the town to design and then build the needed facilities, and provide cost estimates in order to go to a bond vote later this summer. Board will explain process at town meeting – working on Option C – moving the transfer station nearer to Route 140, covering the current sand pile, and constructing a new town garage behind where the current dumpster resides. It was noted that in the past there were many volunteers willing to manage big projects (additions to the school and the community center for instance), but that volunteers are getting older and may not have the energy.

Board reviewed proposed job descriptions for the road commissioner and road crew – tweaked them a bit, requiring a CDL Class A driver's licensed for commissioner, requiring a CDL for the road crew member with support from the town to obtain Class A status as well. Probationary period of three months and a residency requirement of should not shall. Board voted to accept both job descriptions as revised. Kim advised that Vermont Telephone had agreed to do a presentation at town meeting regarding replacing batteries in the fiber optic system when there is a power outage. He submitted three grant proposals to the Tinmouth Community Fund for various ways to address the concern.

FEMA update - requirements seem to keep changing, data is requested, it is provided and then comes another request. Frank signed a letter from the Board regarding road standards.

Solid Waste Ordinance – Cathy met with the Solid Waste and Recycling Committee, has a few more suggestions for fines for offenses, enforcement, education, etc. Board would like input from the Vermont League of Cities and Towns and the Rutland County Sheriff's Department (they will need to enforce).

Gail requested on behalf of the Tinmouth Pond Milfoil Project, that the Board support the application for an Encroachment Permit to keep the SolarBees functioning and to support the application for an Aquatic Nuisance Control Grant for suction harvesting, in Tinmouth Pond. Board voted to support both applications. All voted in favor. Gail expressed appreciation for the support.

Board discussed set-up for town meeting, request will be posted on Front Porch Forum for volunteers to help.

Board reviewed a draft job description for Select Board Assistant – will continue work at next meeting.

Board signed stipulation for new CLA determination.

Board moved its March meeting to the 15^{th,} will ask the Planning Commission to switch, due to a Board member having surgery on the 6th.

Present were members Vito Macaluso, Bob Lloyd, Grant Reynolds, Kim Harbaugh, and Michael Fallar, as well as Gail Fallar, Sec.

Zoning Amendments - Members reviewed Zoning Regulations Article VII - Planned Unit Development, and decided to propose amendment by deleting the entire Article - will retain the Header - simply say "Article VII - Repealed". They also discussed what to do about folks with a dock at Tinmouth Pond wanting a deck to help provide access. Presently they have to apply for a setback waiver from the Zoning Board of Adjustment. The ZBA requested the PC work on a resolution. After contemplation, members decided to add Section 505 to the table of uses (Article V) - as a footnote. "A deck no larger than 300 square feet attached to a dock only needs to meet the side setback requirements", also as a proposed amendment.

Members discussed at length what steps might be taken to encourage owners of older houses falling into disrepair, to find a way to bring them back to livability. The feeling was the houses deserved respect and shouldn't the town do something? No resolutions were found.

Members discussed the search for new members, looking for younger members and women members, a number of folks were suggested, various members offered to contact them to see if they are interested.

Members will look to town meeting for recruitment of new members.

Next meeting is March 8, 2018 – PC and Select Board switched.

Conservation Commission ~ 1/15/18

With thanks to Chuck Bronk. Sec.

Present were members Doug Fontein, Ann Czar, Nelson Jaquay, Robbie Leeds, and Chuck Bronk, as well as Gail Fallar. *Old Business:*

Doug Fontein reviewed the Commission's previous decision to spend up to \$50 on an Amphibian crossing sign. Robbie Leeds reported that the previous estimate had been for lesser quality materials and that a single 18"x18" aluminum double sided sign is estimated to cost \$60. The group agreed that we should get one made and Robbie will ask that it be put into production, with reflective material included if possible. There was a discussion of when and where signs should be placed and it was agreed that the Commission would employ a phone tree to initiate placement. The new sign will require a metal post and Doug agreed to locate one.

Doug reported on quotations from the Northwoods Stewardship Center to cut 1½ to 2 miles of the Ridge Trail to the Cabin. The quote for a Pro crew came close to \$8k for a week's work. Funds to cover this could come from the Hildene Award that Darby Bradley donated to the Tinmouth Land Trust, but all agreed that while this might be an appropriate use of the funds, further discussion was required. Doug agreed to contact VYCC for another estimate.

Doug proposed a day work hike/snow shoe to the Purchase Loop Cabin to affix hardware cloth to the compost bin, and Robbie volunteered to go along.

A discussion of Green Up followed. Nelson agreed to involve the Tinmouth School on Saturday May 5th, not on Friday as has been the practice for the last few years. A note in the Friday News to kids and their parents would most likely accomplish this. Robbie suggested stickers for those involved to go along with prizes as in past, and agreed to explore getting such stickers. Doug suggested that he would ask Cathy to help with advertising the event.

The group voted to accept Barbara Held's resignation with regrets. Ann Czar noted that she was coming to the end of her term and does not want to continue. A discussion of possible new candidates ensued. Members will inquire.

New Business:

Nelson reported on hiking and marking some of the

Drachman trails with Peter Drachman over the Holidays. They flagged a loop trail and noted a side trail. Most of the clearing needs were brambles that might be cleared with a walk behind mower like Adam Guettel's. It was agreed that a work day be set at the next meeting to begin clearing the trails, if it meets with Ruth Drachman's approval.

Doug reported on a contact with Joanne Garton of the Rural Roadside Resiliency. The group deals with techniques for timing the clearing and maintenance of roadsides to maintain species diversity and deal with invasive plants.

Doug also reported on a number of Act 171 Webinars scheduled for the near future. The act provides directions for municipalities to maintain forest blocks and habitat connectors as part of their planning and development.

Present were members Jan Krantz (President), Cathy Reynolds (Treasurer), Ray Pratt (Vice President), Patti Macaluso, Ramsey Yoder, Melody Squier, Asha Carroll McCullough, and Helen Mango (Secretary), as well as Gail Fallar.

The Board members introduced themselves to new member Asha, and Jan gave a brief history of the Tinmouth Community Fund.

Discussion of the upcoming annual meeting on March 3, 2018, at 11:00 a.m. There are three openings on the Board: Ramsey, Jan, and Arne Majorell. Ramsey has decided to retire from the Board. He has a nomination to bring to the floor at the meeting. The Board thanked Ramsey for all his contributions to the work of the TCF. Jan has agreed to continue on. Ray will present information on last year's grants. Helen will make certificates for 2018 grant recipients and will hand them out. Melody will announce K-12 camp grant recipients.

Cathy presented the Treasurer's report.

Board voted to allocate up to \$750 for K-12 camp scholarships. Board voted to allocate up to \$7,000 (plus the proceeds of the Plant Sale) for scholarships. Recipe Corner:

Oatmeal Maple Syrup Drop Cookies

1/2 cup butter or margarine

1 cup maple syrup

1 egg, beaten

1 teaspoon salt

1/4 cup milk

2 teaspoons baking powder

1 1/2 cups flour

1 1/2 cups oatmeal

1/2 cup chopped nuts

1/2 cup seedless raisins

Beat butter/margarine, maple syrup until fluffy, add egg. Mix together flour, salt, baking powder, add to first mixture alternately with milk. Stir well. Add raisins and nuts. Drop by spoonful on greased cookie sheet. Bake at 375 degrees about 15 minutes.

Melissa's Mom's Incredible Raspberry Pie - is being re-printed this month as a few of the instructions were not quite clear last time, sorry!!

Melissa's Mom's Incredible Raspberry Pie

- 1) Crust: 1 pack of graham crackers, \(\frac{1}{4} \) cup sugar, \(\frac{3}{4} \) stick butter (6 Tbls) \(\frac{1}{2} \) pecans (optional) Mix in Cuisinart (if you have one, if not crush crackers and mix by hand) press into 9" pie pan, bake 8 minutes at 350, remove from oven and
- 2) Lightly cover bottom with chocolate chips, return to oven for 2-3 minutes, remove, then spread melted chocolate across the bottom of the crust-not too thick or the pie will be hard to cut. Chill.
- 3) Filling: ½ pint of whipping cream whipped, 8 oz. of cream cheese (softened), ¼ ½ cup confectioners' sugar, gently blend together the whipped cream, cream cheese and sugar, then flop into the cooled crust.
- 4) Raspberry Topping: 2 bags of frozen raspberries or 2 pints fresh. Gently heat \(^1/4\) \(^1/2\) cup of raspberry preserves in a pan on the stove, when liquid, fold the raspberries into the jam to coat. Place raspberries onto pie, top with chocolate chips, Chill. Yum.

~ Rutland County Sherriff's Department News ~

Proposal for combined patrol by the Rutland County Sheriff's Department for the towns of Ira, Middletown Springs, Tinmouth and Danby. The Rutland County Sheriff's Dept. is proposing that the above towns each contribute 10 hours per week to this combined patrol. Currently each town pays for X amount of hours each week and when those hours are complete for that week the town gets no further patrol until the following week. The combined patrol will give each town access to a Deputy any time during the 40 hour a week patrol so the issue of town X using up its hours is no longer an issue.

An example of this would be if town X had a contract for 10 hours a week and those hours were used up on the first two days of the week for an investigation this would leave the town with no coverage until the following week. The combined patrol would alleviate this situation by allowing the Deputy to respond to town X at any time while on patrol in any of the 4 towns during the 40 hour patrol week regardless if town X had used there hours for the week.

The one deputy assigned to this patrol would adjust the hours the following week to keep a balance of the hours each individual town receives keeping the hours in check to avoid a deficit or an overage of hours. Regardless of the hours used in any of the towns each week a Deputy would respond to a call for service any time during the 40 hour patrol week.

Currently these are the hours each of the four towns contract for.

Danby 10 hours each week.

Ira 5 hours each week.

Tinmouth 6 hours each week.

Middletown Springs 5 hours each week.




