May 11 this year – from 8-10 a.m. We will be selling locally grown and dug perennials to benefit the Tinmouth Scholarship Fund. This event is the primary fundraiser for Tinmouth Scholarships. In 2018 we awarded \$11,000 to 13 scholars. Help us continue and grow!

We welcome diggers (those who can dig and/or donate special perennials that are weed-free). We need to manage varieties and quantities, so please call or email me before you dig!

We are looking for volunteers to pot and mark plants on **Saturday and Sunday, May 4 and 5**. Typically our diggers drop off plants on Friday and Saturday morning and we pot on Saturday and Sunday. We strive to have all our plants potted and marked the week before the sale.

We need potters at 143 Channel Road on **Saturday**, **May 4, from noon to 5 p.m. and Sunday morning, May 5, from 10 a.m.** until we are done. No experience necessary! We work in any weather, so come prepared to be outside (that could mean hats and gloves or sunblock and lemonade). A quick email or call to let me know you can help would be appreciated so I know how many folks to expect. We may also do additional potting on other days, so if you can be available during the week, please let me know and I will call you if there is potting to do.

We always accept donations of plastic pots 5" or larger. Please: Round and square pots only. Pots can be left on the porch at the Town Office, or dropped off at 143 Channel Road.

Plant sale set-up is Friday May 10, at the Old Creamery (next to the Town Office), and we can always use help unloading and organizing plants by variety. We start first thing.

This is a family and kid-friendly event so please come with your young ones so they can share the fun (and maybe learn a little about civic responsibility and protecting our environment).

There won't be a Green Up activity at the school this year in an effort to get full involvement on Saturday morning. So this is your chance to be part of the team! People are also welcome to do DIY Green Up by getting bags from the Town Office (there are bags there now) and cleaning a section of roadside as your schedule allows. ~ Recipe Corner ~

Leek and Potato Soup

3 Tablespoons butter

6 Leeks (Leeks can be gritty – cut off roots, and coarse green tops, slice down remaining green top lengthwise and rinse well)

3 stalks celery with leaves, sliced very thin

3 cups water

2 medium potatoes, peeled and diced

3 cups milk

Salt & pepper to taste

Melt butter in a large kettle and add leeks and celery. Cook about 10 minutes over moderate heat, stirring often. Stir in one cup of water, cover and cook 10 more minutes. Add potatoes and two more cups of water, cover and cook another 10 minutes. Stir in milk. Cook another 10 minutes until potatoes are tender. Add salt and pepper to taste.

Dear Friends,

I am writing this month's *Tales* article as one more item on my "to do" list before setting off for Ireland. As a last assignment at Green Mountain College, I am taking a group of students on a pilgrimage in Ireland.

I love the concept of a pilgrimage, because it is much more than a trip. When we travel to a new place, we approach it with an openness that is often difficult to muster in the ordinary circumstances of our everyday life. A pilgrimage builds on this openness and helps the traveler, or pilgrim, to set the intention for a transformative experience.

Dag Hammarskjold wrote, "The longest journey is the journey within." A pilgrimage is a journey out to somewhere new and exciting in the world, of course, but it is also a journey deeper into one's own self. Ideally, when you return home after a pilgrimage, you will return with a new perspective on your life. You may even have a renewed sense of who you are, and what gifts you bring to the world.

There is a wonderful story about Joseph Campbell's interaction with a woman who was embarking on a long-anticipated trip. She excitedly told him of all her plans, the reservations she had made and the expectations she had for each place. When she finally ran out of breath, the master mythologist calmly commented, "Dear woman, I do hope that things do not go as planned." What he was getting at was the importance of leaving room in your journey for serendipity, for mystery and even magic to happen.

So, when the students ask me what they can expect, I love telling them that there is plenty they can expect to have happen while we are traveling through Ireland, but what they will most likely remember are the things that we cannot possibly expect. Part of preparing for and participating in a pilgrimage is learning to leave room for the things you cannot plan. This is where the Holy enters the experience. These are the things you will speak of later in the hushed tones of awe and deep gratitude.

I believe every day is a pilgrimage of sorts, even if we don't go anywhere out of the ordinary. I encourage all of us to approach our days like this, to anticipate something magical and transformative to happen when we least expect it.

The year has flown by quickly! We are in the final eight weeks of school. The final two weeks in June have already been scheduled with field trips, graduation ceremonies, and field day activities. This year, the older students are visiting Howe Caverns. Younger students will visit Hildene and Vermont Institute of Natural Science.

On Friday, April 12th, our sixth grade students joined sixth graders from across the district for geocaching at Pine Hill Park. This team building activity is part of a grant program designed to introduce sixth graders across the district to the peers they'll be studying with at Mill River Middle School in the fall of 2019.

We are ecstatic that she agreed to take on a classroom teacher role! We are also grateful that the budget was approved. The school budget included funding for an additional teacher due to the growing student population at TMS.

Changes in next years preK program include adding after-school care for our preK students. The program will run Monday through Friday from 8:00 AM to 12:00 PM *for 3 year* olds and will run Monday through Friday from 8:00 AM to 3:00 PM *for 4 year olds*. Children can be dropped off at 7:40 AM. After program childcare will be offered from 12:00 PM to 5:30 PM Monday through Friday. Costs for after-school program childcare will be \$10 per school day, per child. Subsidies for this cost are available for those who qualify.

~ MRUUSD Pre-K Expansion Announcement ~

The Mill River Unified Union School District is excited to announce a district-wide expansion of our prekindergarten programming. MRUUSD believes that high quality early education is key to the success of our communities and students. In addition, we recognize the need for childcare opportunities for three and four year olds in our region and very much hope that our expanded programs will provide families with rigorous, exciting, and affordable choices for early education and childcare in each town we serve. Although each school's prekindergarten options will vary slightly, each program will offer after-program educational childcare to ensure that working families have the ability to have students cared for in our district schools from 8-5:30 each school day following the school calendar. Registration for MRUUSD pre-k programs follows existing policies.

Tinmouth Mountain School Pre-K program is unique in that children develop a sense of stewardship for the natural environment through place-based education. Our outdoor classrooms afford students opportunity to observe, wonder, explore, and connect to the natural world they live in. Academics are emphasized through an environmentally focused curriculum explicitly designed to address early childhood education proficencies.

At Tinmouth Mountain School the pre-k instructional program will run Monday through Friday from 8:00 AM to 12:00 PM *for 3 year* olds and will run Monday through Friday from 8:00 AM to 3:00 PM *for 4 year olds*. Children can be dropped off at 7:40 AM. After program childcare will be offered from 12:00 PM to 5:30 PM Monday through Friday. ~Meeting Highlights~

Select Board ~ 4/4/19 Special Meeting

Present were members present Michael Fallar, Frank Sears and Cathy Reynolds, as well as Don Woods, Eng., Jo Reynolds, Grant Reynolds, Eric Buffum-Road Commissioner, Ken Krantz, Jan Krantz, Doug Fontein, and Gail Fallar – Select Board Assistant

Cathy advised the purpose of the meeting was to choose a location for the proposed new town garage. All adjoining neighbors were notified via email or in person, and presented with a copy of Mr. Woods' proposal from 3/14/19. She noted the Krantzes politely declined the idea of a land swap or sale that was suggested in the proposal.

Board discussed Alternatives, Michael advised he preferred #1, with the possibility of decreasing the size of the salt shed to hold half a year's supply of salt. Frank also preferred #1. Outdoor storage area needed was discussed, where it should be, what it was needed for (culverts, gravel, etc.). Eric advised he preferred #2 or #3 as the building was further back from the road and would allow the ability to drive through it. #3 would move the access to the transfer station.

Ken and Jan advised that they were not interested in selling or swapping the town any land. Their concern is for the salt that is making its way toward their garden. Ken noted that the natural lay of the land accounts for much of the water draining towards them. The sand is not so much a problem, but the salt is. He inquired about the size of a retention pond.

Don responded that has not yet been determined, but a state storm water permit is needed. Storm water needs to be treated before it is released – hopefully sheeting as it spreads out. A permittee has to look beyond their own borders to consider consequences on adjoining properties. A stormwater permit is needed if there is or will be more than an acre of impervious surface – roofs, driveways, etc.

Eric advised that the sand does not have much salt in it, evidenced by the large chunks that were frozen this year, and that the salt is stored inside on an impervious surface.

The Krantzes were asked if they would consider a boundary adjustment to accommodate a better way to treat the stormwater. They were skeptical, but willing to look at details.

After discussion, Board voted to approve Alternative 1 and 2 - (placing the new garage between the old one and Route 140).

Cathy then inquired about next steps and time line from Don. Don responded that he will begin to work on storm water issues, will need to survey topography and lot lines. Due to an equipment breakdown, he will not be able to get this work done for a month or two. When the field work is done (needs to dig a test pit or two as well), a preliminary report will be available, which the Board and an architect can use to determine a solid number to take to voters for their consideration. Final state permitting would not be done until voters have authorized moving forward.

Select Board ~ 4/11/19

Present were members Cathy Reynolds, Michael Fallar, and Frank Sears, as well as Sherry Johnson, Kim Harbaugh, Michael Fannin – EMC, Jo Reynolds, Grant Reynolds, Eric Buffum-Road Commissioner, and Gail Fallar – Select Board Assistant

Board reviewed agenda – added Resilient Roadside Project Report, liquor license for Casey/Snack Bar, resignation and ZBA appointment.

Highway ~ Eric reported the new truck's hydraulic issues have been straightened out, Ronnie's truck is getting work done – has been leaking anti-freeze internally, not sure if it's still under warranty. He advised two rounds of pot hole filling had been done, lots of mud. He handed out road inventory reports, software is not working properly, still working on it to produce estimated costs. Board asked him to prioritize which roads need what for the May Board meeting. Board talked about repaving cycle.

Michael Fannin raised concerns with the condition of the **small bridge on Route 140**, just before it intersects with Route 133. Eric will take a look.

McCoy Road culverts bid specs – Gail and Eric are still working on them. Board wants all bidders to use the same form – two projects to be bid separately, but awarded on the combined cost of the two. Board authorized Frank to oversee the bid sheet. Board voted to go out to bid for the culvert work on McCoy Road, pending approval of bid sheet.

New Town Garage ~ Board reviewed email correspondence from David and Carleen Eaton regarding the location of the proposed new town garage, buffer area – row of trees, re-location of culvert storage area. After discussion Cathy volunteered to respond for the Board that they are taking the requests under advisement.

Resilient Road Project ~ Cathy reported that Tinmouth was one of 10 towns chosen by Vermont Dept. of Forest & Parks for this endeavor. There were 23 miles of road inventoried with 14 maps resulting. The Tree Policy Committee and the Road Resiliency Committee met with Joanne Garton from F & R, to review the draft report. A number of issues were discussed – roadside mowing should be done before June 30 to help deal with life cycles of invasive plants (poison parsnip needs at least two mowings); using standing corn as snow fence; ash trees and how to plan for their ultimate decline; tree policy wrap-up.

Michael Fannin questioned the **ditching project on Gulf Road** near his house, Eric advised it would be stone lined and would help make the road better and easier to maintain.

Old Creamery ~ Grant, as Old Creamery Committee Chair, reported the OCC was hoping to do three projects this year. Paint the south and east sides, create a "clean" room inside for storage, and provide electricity to the building. The OCC asked the Select Board to run a line underground from the town office, the OCC will pay for the wiring inside the building. Another possible project would be to build a ramp to the door on the north side to access the clean room. After brief discussion, Board asked the OCC to obtain estimates and bring them to the Board.

Local Emergency Management Plan (LEMP) ~ Michael Fannin, as Emergency Management Coordinator, reviewed the draft LEMP created by himself, Marshall Squier, Sherry Johnson, David Birdsall and Gail Fallar. This replaces the LEOP. After discussion, Board voted to accept and adopt as amended and presented. Board authorized Cathy to sign.

Solid Waste Ordinance ~ amendment regarding enforcement needs to be added, added to agenda for next month.

FEMA Monitoring ~ Gail advised the town had been monitored by the Public Safety Department regarding compliance with federal and state regulations for FEMA reimbursement for the storm damage in July 2017. Board will need to adopt a separate conflict of interest policy for federal projects, other recommendations were suggested. Many practices are correct, just not written in policy.

Village Center Designation ~ Michael Fallar, as Planning Commission Chair, advised the Planning Commission is working on an application for Village Center Designation for the center of town. There is a proposed map already in the Town Plan, though a state board will make the final determination. The major benefit to Tinmouth is raising the possibility of future state grant approval. Towns with VCD get extra points in the grant process. Board will need to approve at a later date.

Health Officer Compensation ~ Frank noted more training is being required and the job is getting much more complicated. Cathy moved and Michael 2nded to compensate the Health Officer at \$15 per hour. Both approved, Frank recused himself as he is currently the H.O.

Bonding ~ Gail reported the process for bonding for a major project - hire a bond attorney, professional audit, Select Board Resolution, town vote, application to the Bond Bank (next round of applications due in early December).

Mail/Correspondence - Board received copy of public records request from the town of Wallingford regarding Stan Taylor's property on Tinmouth Pond Road. No Board response is needed, town clerk will send documents requested. At issue is the location of the town line. Wallingford agreed two years ago that the property maps showed the Taylors house was located in Tinmouth,

so its value was added to the Tinmouth grand list and removed from the Wallingford grand list. The current Wallingford Select Board wants to reverse that. Other land owners were affected as well, with land now being taxed in Wallingford.

Resignation ~ Amy Martone, newly elected member of the Mill River Unified Union School District, submitted her resignation from the Safety and Wellness Committee. Board accepted with regret, thanking Amy for her service.

ZBA Appointment ~ Board voted to appoint Vito Macaluso to the Zoning Board of Adjustment.

Liquor License ~ Board approved and signed Liquor License for Gregg and Tina Casey for the Tinmouth Snack Bar.

Conservation Commission ~ 4/15/19 – Special Meeting With thanks to Chuck Bronk, Sec.

Present were members Doug Fontein, Jo Reynolds, Jeff Ams, and Chuck Bronk, as well as Gail Fallar.

New Business:

Planning for Green Up Day – Tasks:

Banner to fence two weeks before event, Adopt a road poster board, Sign up sheet with emails for participants, Pick up bags and maps from Town Office, Saturday 8:00AM Prize category poster, MC awards event, Bottles with bucks at roadsides, Call and invite five people to participate, Advertise event at Tinmouth Mountain School, Friday Round-up, Sandwich Board sign (2) for Town Office. Vermont Coffee contribution. Posters with added info to Transfer Station, Town Office, Community Center, Notice on Front Porch Forum - All volunteered for various jobs.

Materials to bring to event:

Coffee, cups, cream & sugar, Ice cream, scoops and cones, Hand sanitizer, Latex gloves – large, prizes, including last year's left overs and new acquisitions,

Old Business:

Amphibian crossing signs are up. Robbie has ordered two more signs for delivery in 2 weeks. The new signs should probably go on North End Road at the Channel culvert and on North East Road between the top of the hill and Route 140.

Switch Backs needed on the Ridge trail. Doug reported that Adam Guettel is OK with the concept but would be unavailable to review the extent and location till September. He agreed to no change in the easement only changes on the ground. The location is between the meadows and the saddle.

Drachman trail. Doug circulated a MOU for review. Members discussed the next steps in establishing the trail.

Jo mentioned an "Invasive" walk at the end of April at Equinox that she plans to attend and offered to forward the information to Commission members via email.

Members had a general discussion of map making and the need to fill in the past, major efforts of Bob Lloyd in the future. Next meeting set for May 20th at 7:30 PM

Planning Commission ~ 4/22/19

Present were members Michael Fallar, Bob Lloyd, Vito Macaluso, Grant Reynolds, Andy Gilmore, and Larry Carabeau, as well as Barbara Noyes Pulling, Rutland Regional Planning Commission, and Gail Fallar.

Enhanced Energy Planning ~ Michael welcomed Barbara and thanked her for attending. Barbara advised that the draft she had prepared -32 pages but that included 14 pages of a checklist for towns to consider at they write their enhanced energy plan - used data compiled by the state and broken down by town according to its percent of population in the RRPC's 27 towns -Tinmouth's is 3%. She had included some language other towns had used for TPC to consider. Members questioned the accurateness of the numbers - many were simply out of whack for Tinmouth, and members felt uneasy using those in a plan. Barbara noted that the TPC had to start somewhere, and that the state required the information as a baseline.

There was MUCH discussion ~ about the process; what the end result might be (is it worth the effort); why the state does not mention fire wood as renewable energy (TPC wants to); what steps the TPC will take to meet the 2050 state target date for being 90% renewable; adding "hypothetical data", "best available data", as caveats; that towns can't force property owners to install solar or other renewable devices; that the Tinmouth Energy Committee has no energy when it was suggested they do some of this work; whether the current town plan's energy section has enough strength in it to protect the town in the event a commercial entity wanted to build a renewable project; and what role Tinmouth will play in addressing climate change.

In the end, members voted to have Grant and Bob meet with Barbara to review the various draft versions and report back at the next meeting.

Vito volunteered to peruse the recently received *Mapping Vermont's Natural Heritage* to see if there are any aspects that the TPC could use – many steps have already been taken to protect Tinmouth's rural character and enhance wildlife habitat.

Next meeting was set for Thursday, May 16th, 2019.

Tinmouth Community Fund ~ 4/15/19

Present were members Jan Krantz (Chair), Cathy Reynolds (Treasurer), Nikki Pfeiffer, Asha Carroll McCullough, and Melody Squier.

Jan advised the presentation by Elisabeth Marx needed to be postponed due to illness.

Tree Placement in recognition to Ramsey Yoder's years of service and contribution to the Tinmouth Community Fund: Jan and a few others met about the tree location on the town green. The location suggested was too close to the sledding hill after input from the meeting attendees. Further discussion about perhaps planting the tree near the benches near the playground.

Cathy suggested talking to school principal Maureen Fitzgerald-Riker and get input for the Select Board to consider in making their decision about the location of the tree.

Capitol Campaign:

Right now the Tinmouth Community Fund Continuing Education Scholarship Fund provides about \$11,000.00 for scholarships.

Cathy met with Elisabeth Marx from the Vermont Community Fund and learned a few key points.

People give when there is a need. If you can explain the need and the timeline - people are willing to give bigger and need to be asked.

Jan asked what if the TCFCESF receives \$25,000.00 in donations. How is donation appreciation acknowledged? At the award ceremony to the donor(s)?

Cathy, yes if the donor would like that - otherwise the donor stays anonymous.

How, when, where do we have an event to launch the Capital Campaign?

Group discussed and agreed that the Award Ceremony would make the most sense.

Board voted to create a Capital Campaign for the Tinmouth Community Fund Continuing Education Scholarship Fund.

Board voted to allocate an additional \$280 for Tinmouth Community Fund Continuing Education K-12 Camp Scholarships for this year.

Publicity for Scholarships? Something in Tales?

Yes, and Cathy has been in contact with Cassie in Guidance at the Mill River Union High School and Cassie has posted and directly spoken to students about the scholarship opportunities.

She will reach out to her again. There is also one child at Long Trail who would be eligible.

Plant sale.

This year Cathy is really looking for help with the plant sale. Needs help with the front end part of the plant sale especially. Help with digging, potting, moving, signage. etc. She would really like to pass the Plant Sale baton to the next generation of gardeners.

Also - donations of 8-10" pots are always welcome.

Old Creamery Committee ~ 4/20/19

Present were members Michael Fallar, Stan Wilbur, Grant Reynolds, and Vito Macaluso, as well as Gail Fallar, scribe.

Gail, as Town Treasurer, reported a current balance of \$2,454, all bills paid. Report accepted.

Michael reported the claps on both the south wall (foundation wall) and east wall (lower section) had been replaced. Most were painted (by Vito, Jo and Grant), but he needed a few more which are just primed. He has asked the road commissioner to help re-grade the south side when time allows. Some fill is needed, a couple of stumps need to be removed and stones need to be moved or removed.

Members discussed painting miscellaneous spots – north wall – door, trim, a few claps – THGS members will take care of those. Michael volunteered to paint on the lower east wall.

Grant reported that the Select Board has requested an estimate to electrify the old creamery building – running a line from the town office to a new box and a light or two in the "clean room". They also want an estimate and sketch for a ramp/deck to the door in the north wall.

Following a site visit to help determine work need in of doing

Members discussed and prioritized projects for this year \sim

- 1. Paint south and east walls. Re-nailing where possible, no replacement of claps. Grant offered to pay for the south wall (thank you very kindly).
- 2. Electricity from the town office to the old creamery building, clean room to be wired to code with outlets and overhead lights on 2-way switches. Line to be run in conduit.
- 3. Clean room build a storage room 10 ½ feet by 14 feet using the door on the north side of the building. Ceiling joists need replacing and ½ inch sheetrock, walls to be ¼ inch sheetrock covering old surfaces, a new wall on the south and a small spur on the west. Window to be re-glazed to allow in light.
- 4. Ramp (covered) from porch to door on north side entry to clean room.

How many get done will be determined by cost and fundraising (Stan has a plan).

Members also discussed re-glazing the window on the north side and the door on the west side (it's only missing three panes).

Members also discussed hanging the upstairs door – it seems in good shape – but needs paint.

Bids specs are needed for painting the south and east walls; for running electricity from the town office; and for

clean room's construction. Gail and Michael will work on those.

Stan volunteered to vacuum the area to be enclosed for the "clean room" - it will be used for storage (Conservation Commission signs, Historical Society), by folks using the bake oven, etc.

Tree Policy Committee & Road Resiliency Committee Joint Meeting ~ 4/9/19

TPC and RRC members present: Cathy Reynolds, Doug Fontein, Eric Buffum, David Birdsall, and Gail Fallar, as well as Joanne Garten, Vermont Department of Forest and Parks via telephone

Members reviewed and discussed Joanne's report "Rural Road Resilient Right-of-Ways Vegetation Assessment". Last summer several roads were inventoried in detail, 14 maps created showing various data useful in creating road side policies.

There were several recommendations and action items suggested. These included:

* roadside mowing before the end of June to help deal with life cycle of certain invasive plants – twice or more per year for poison parsnip;

* ash trees - EAB (Emerald ash borer) management

* snow fence – would farmers leave corn standing to act as one

* town tree policy

Other concerns were:

* hazardous trees

* utility line clearing – leave under-brush

* need to prioritize Eric and David's dangerous tree list and provide information to Select Board for budgeting as some will need to be removed by a tree service not the road crew

Discussion about which should be undertaken and when.

Much discussion about the plight of ash trees, 99% will die. There is time to plan. Need to cut dead trees now, keep wood local so if there are any bugs they don't get moved to another area. Tinmouth has many ash trees, how will they be removed, replaced, etc. Landowner owns the wood in the town's right of way, what is policy for cutting them all along one road? Does town need to notify each landowner? There are apps available to help inventory them. Also need to be mindful of ash trees out of the right of way that will fall into the road.

Ash trees in the town right of way – town management

Ash trees in utility right of way – need to contact them about their plans

Ash trees on private property with impact on town road – need to educate landowners

Discussion about tree policy – Tree Policy Committee put draft on hold last year, pending Joanne's report and assistance with developing it. She will forward to other members of her department for review and suggestions. Discussed need for snow fence on a number of roads, lack of roadside trees allows the snow to blow. Snow fences only work some, snow banks used for snow fence works some, it was suggested that in some states, farmers are paid to leave several rows of corn standing -100 feet from the road. Would that work here, are there any towns in Vermont doing that? Could round bales be used?

Joanne will take comments under consideration and finalize report, as well as assist with the tree policy and snow fencing.

Solid Waste & Recycling Committee ~ 4/30/19

With thanks to Helen Mango, Sec.

Present were members Wheaton Squier, Gail Fallar, Jonathan Czar, Chris Martone and Helen Mango.

Gail provided a update on the Transfer Station – current plans are for the new Town Garage to go between current garage and Route 140, and for the salt shed to go in back to the west of the current brush pile. Aside from that, the Transfer Station will stay the way it is. The civil engineer is still working on storm water issues.

The updated Solid Waste Ordinance was discussed. Members approved an amendment from the Vermont League of Cities and Towns. This will go to the Select Board on May 9, 2019. If they adopt the ordinance, people have 60 days to petition it for a special town meeting.

Chris reported that Charlie will be back at work this week. He and Gunner Morris and Gail went to an e-waste seminar that clarified current disposal rules. Gail reported that the cost of recycling went from \$48 to \$100 per ton. There is a glut of recyclables everywhere, but it is in Vermont state statute that all recyclable materials must be recycled.

Wheaton gave an update on his composting set-up.

Safety and Wellness Committee ~ 4/30/19

Present were members Chris Martone, Ronnie Crossman and Gail Fallar.

Gail advised that Amy Martone had resigned as she was elected Tinmouth's representative to the Mill River Unified Union School District.

No safety grant applications this round, more research is needed about fire detection systems.

Current plan is for the transfer station to stay put, and a new town garage built between the old one and Route 140. Members talked about gravel or concrete pad under the roll-offs, moving the metal dumpster, etc.




Annual Wallingford Bike Safety Day: Rides Again On May 11th, 2019


