

On the evening of June 2, 2019, a Katsura tree, recently planted in the center of town, was dedicated to honor **Ramsey Yoder**, and all that he has done for Tinmouth.

Following is what was read at the event.

Ramsey, it is a pleasure to be able to share some thoughts relative to the Katsura tree we planted to honor you this spring. It seems that a tree is a great metaphor for all that you have done for Tinmouth. If we look around our town, we can easily see and experience the results of seeds you have planted in this community over time. You had a vision for Tinmouth, and you challenged us to think about possibilities and to dream big, but one step at a time. First, how can we transform that ugly green metal firehouse that sits in the center of town? Next, do you think we could build a community center onto the school, relying mostly on the talents and natural resources here in Tinmouth?

With your vision and support, these projects went from a dream to a reality, and in the process brought us together as a diverse community. In 1999, to ensure all of this continued into the future, you stepped up to lead the creation of the Tinmouth Community Fund and continued on in that role for many years. And here we are in 2019, 20 years later, the Community Center is a versatile and vital part of the community, and your ideas have continued to grow and branch out, so we now have three programs under the Tinmouth Community Fund: the Community Grants, the K-12 Scholarships, and last but not least, the Continuing Education Scholarships, which we are celebrating this evening. Ramsey, the seeds you planted over 20 years ago, have grown and are firmly rooted in this special community, making it a more

beautiful and better place to live now, and into the future. The Katsura tree is an unusual one, hard to find, and beautiful to see. Once again, you inspired us to think and look broader. It is with deep gratitude that we dedicate this Katsura tree to honor all that you have done for Tinmouth. Thank you!

#### **BLT Macaroni Salad**

- <sup>1</sup>/<sub>2</sub> cup mayonnaise
- 3 tablespoons chili sauce
- 2 tablespoons lemon juice
- 1 teaspoon sugar
- 3 cups cooked elbow macaroni
- $\frac{1}{2}$  cup chopped tomatoes
- 2 tablespoons chopped green onions
- 3 cups shredded lettuce
- 4 bacon strips, cooked and crumbled.

In a large bowl, combine the mayonnaise, chili sauce, lemon juice and sugar. Add the cooked macaroni, tomatoes and green onions; toss to coat. Cover and refrigerate at least 1 hour. Just before serving, add lettuce and bacon; toss to coat.

#### Select Board ~ 6/13/19

Present were members Frank Sears, Cathy Reynolds, and Michael Fallar, as well as Eric Buffum-Road Commissioner, Jo Reynolds, Grant Reynolds, Mildred Traina, Kim Harbaugh, and Gail Fallar – Board Assistant.

Board reviewed agenda, Eric requested to go first, added Vermont Community Leadership request.

~ Highway ~

**McCoy Road** ~ Eric reported project culverts were on site, by-pass culvert has been installed.

**Gulf Road** ~ Eric reported work was mostly done, still has to change one culvert but won't get to that by the June 30<sup>th</sup> deadline. He decided not to install the extra one due to opposition from a local farmer. Board inquired about total cost, not available at this time. Eric noted he had recently purchased a hay bale mulcher and wondered if the town would like to buy it or rent it from him. Board took under advisement, will consider at next meeting.

**New Town Garage** ~ Don Woods advised he will not be able to continue as engineer. Board reviewed proposal from Otter Creek Engineering. After discussion, Cathy moved and Frank 2nded to hire Otter Creek for ground work, storm water planning and state permitting. Once permits are obtained, better cost estimates are possible before the bond vote. Cathy and Frank voted in favor, Michael abstained. Motion passed.

**New One Ton Truck** ~ Eric has not had time to prepare bids, will try to have ready for July Board meeting.

**Fuel Bids** ~ Board requested fuel bids for July meeting.

**Road Complaint** ~ Mildred expressed concern with recent cutouts made on her property. She advised they now direct water onto her property. She called the road commissioner and did not receive a reply, so she came to the Board. Has lived in town for 37 years and doesn't understand why this is being done now, rather than installing culverts. Eric advised that it was done to get water off the road rather than having it run down the road, and that it's been a really wet year. After discussion, Board asked Eric to take a look and report back. Eric asked Frank to go along.

**Roadside Mowing** ~ Board voted to again hire Hollis Squier to mow roadsides as a sub-contractor. Michael recused himself as Hollis is his uncle. Board would like it done as soon as possible to help control poison parsnip (needs to be cut before it goes to seed).

**Roads** ~ Eric presented Board prioritized list of roads and their conditions and work needed, no cost estimates were included.

**Gulf Road** – **Class 4 Section** ~ Eric advised it was not yet open, needed some gravel, trying to get grant work done first.

**Summer Road Crew Help** ~ Board discussed protocol, need to advertise on Front Porch Forum and Tales, CDL preferred, part time, \$15-\$20 per hour based on experience. Eric does have someone who may be interested.

**Members Concerns** ~ Board members noted there are grumblings about when roads will be graded, Eric advised as soon as the work on McCoy Road is done.

#### ~ General Business ~

**Wallingford Town Line** ~ Board reviewed and signed letter to the Wallingford Select Board regarding the town line, once again asking them to attend a meeting in Tinmouth and to leave the grand lists as agreed in 2017 in regards to Stan Taylor's property until both Boards can agree on a process to resolve the issue.

**Solid Waste Ordinance** ~ Board reviewed and accepted comments/suggestions from Pam Clapp, our Solid Waste District Coordinator, regarding the proposed ordinance. Board voted to accept and adopt the Solid Waste Ordinance.

**Old Business** ~ *Right of Way Use on East Road* – no progress. *Trash on Mountain View Road* – some has been moved, more remains. Frank advised as Health Officer he was still trying to get Sarah Munger to clean up the trash on *Maplebrook Lane*, she advised she would begin within a week.

**Glebe Lands** ~ Grant advised that recent legislation dealt with glebe (lease) land - lots created with the first laving out of the town in 1761 for various purposes including for the propagation of the ministry. Church of England, etc., and much like ancient roads, can create a cloud on a property's title. The Legislature created a path for them to be extinguished if a town decides it no longer wants/needs them. There appears to be two such glebe lots - near the center of town and to the southeast of Tinmouth Pond. "Rent" was collected by the town until 1983 in Tinmouth and turned over to the school. Grant volunteered to research and create a list for the Board to consider, the original two lots having been subdivided a number of times in the last 200 years. The Board needs to decide by January 1, 2020.

**Financial Management Questionnaire** ~ Board reviewed and accepted document prepared by the town treasurer as required by state statute and the State Auditor of Accounts.

**Restoration and Preservation Reserve Fund** ~ Board renamed Records Restoration Fund to the "Restoration and Preservation Reserve Fund". The Restoration and Preservation Reserve Fund shall be used solely for restoration, preservation, digitization, storage, and conservation of municipal records. New legislation increased the per page fee for recording to \$15 and requires \$4 per page be set aside for this fund. **Unlicensed Dog Warrant** ~ Board signed unlicensed dog warrant, giving the Constables the authority to destroy those dogs remaining unlicensed. There are 10 or so owners who have yet to license their pets.

**Recycle Fees** ~ Board answered questions from Pam Clapp regarding whether the town was going to increase trash fees or start charging for recycling as the cost of processing recycling has gone from \$48 per ton to \$100. Board will consider at its next meeting, asked assistant to research what other towns are doing.

**Energy Committee** ~ Board appointed Todd Dennis to the Energy Committee.

**Federal Project Purchasing Policy** ~ Gail advised that a 'may' had to be changed to 'shall' in regards to the conflict of interest, in order to be approved by the Department of Public Safety and FEMA. Board made the change to the draft. This change had to be made by 6/14/19 or the town would no longer be eligible for federal money.

**Vermont Community Leadership Summit** ~ Vermont Council on Rural Development requested a nominee from the town. Michael volunteered to attend, Frank will go if Michael is unable.

**Member Concerns** ~ Michael advised that Gunner Morris, transfer station attendant, was willing to use the old town backhoe to crush trash and remove snow, and maintain it if need be. He used to be a big equipment operator. Board took under advisement.

#### Select Board ~ 6/27/19 ~ Special Meeting

Present were members Michael Fallar and Frank Sears, as well as Gail Fallar – Select Board Assistant

After brief discussion, Board voted to sign a letter of intent regarding the State's FY20 Grant In Aide program for storm water control.

After brief discussion, Board voted to authorize Michael to sign documents: for a Better Roads Grant (\$7,622); for a road and culvert inventory contract with Rutland Regional Planning Commission to perform that road and culvert inventory and prepare a Road Stormwater Management Plan for \$7,622; and for the Aquatic Nuisance (Milfoil) Control on Tinmouth Pond for \$3,264. Select Board Chair, Cathy Reynolds was out of town and the documents were time sensitive.

Board briefly discussed the Gulf Road Grant In Aide Project and the need to better anticipate cost in relation to grant reimbursement.

#### **Tinmouth Planning Commission ~ 6/27/19**

Present were members Kim Harbaugh, Bob Lloyd, Pat Psholka, Vito Macaluso, Grant Reynolds, Rainbow Squier, Larry Carabeau, and Michael Fallar, as well as Barbara Noyes Pulling, Rutland Regional Planning Commission (RRPC), Gail Fallar, Secretary, and Todd Dennis and Ray Pratt – members of the Energy Committee.

Bob had emailed the latest draft of the proposed Enhanced Energy Plan. Black and white paper copies were passed around. Maps are letter size and hard to read, they are better in color.

Members again discussed concerns with the energy planning process and flaws in the initial data. Barbara and Bob both advised again that the data was prepared by the state and is the best available at the moment. They urged members to move past that and consider ways the town can work to address climate change, reduce energy cost, obtain more solar, obtain more renewables, look at/plan what can be done.

Members reiterated they do not want to identify specific properties or contact landowners about possible "preferred" sites. A member of the public had suggested doing that so owners could be prepared in the event a potential solar developer approached them. Barbara noted preferred areas are general in nature and other areas could be explored even if not on the map.

PC discussed process, Barbara clarified that the EEP cannot be a standalone plan, it has to be attached to the current town plan, either as an appendix or as a regular section. The current town plan already has an energy section. Having the enhanced plan can give the town substantial deference in the state approval permit process.

Grant noted the PC needs to sit down and carefully read the draft, it is an important document that commits the town to action. Bob again noted he does not want to debate the data provided by the state, Grant again noted that there is no Tinmouth-size data available. Barbara noted the only commitment in the plan is to action, not to the correctness of the data.

Bob read a caveat paragraph describing the data and issues the PC has with it, to be included in the EEP.

Gail questioned the "shall" in the last two pages that contain action the town must take. She would prefer "should", as the PC cannot tell the Select Board Assistant or the Select Board that they shall do this or that. Barbara noted that shall is more compelling.

Bob noted that the Energy Committee was invited to review the document as they were also directed to take multiple actions. Ray and Todd advised they would be willing to take a look. Cathy Reynolds is also on the Energy Committee.

Members then proceeded to review the document page by page, making a few suggested edits. Barbara will check on the data of some charts, whether Vermont has impact statements, and whether more teeth can be added to the decommissioning requirements.

Several members advised that the Town needs to do something to address climate change, this is a good start and that it can be amended in the future as energy use and/or needs change. Pat suggested inviting Annette Smith to speak to the Planning Commission regarding enhanced energy planning. She and Grant attended a meeting in Weathersfield where Annette spoke. After brief discussion, members decided by a show of hands to do this and invite surrounding towns planning commissions as well.

Gail advised that she has not had time to work on Village Center Designation and asked for help.

Next meeting was set for Thursday, August 15, 2019 - no meeting in July. Energy Committee will meet before then to review the proposal. It is anticipated that PC members will vote at the meeting on moving the plan forward.

#### Tinmouth Community Fund Board ~ 6/20/19

With thanks to Helen Mango, Secretary

Present were members Jan Krantz (Chair), Ray Pratt (Vice Chair), Cathy Reynolds (Treasurer), Nikki Pfeiffer, Asha Carroll, and Helen Mango (Secretary), as well as Gail Fallar, town treasurer.

Cathy passed around a few thank-you notes from recipients of this year's TCF scholarships.

<u>Treasurer's report</u>: Cathy and Gail reported that the TCF has a town checkbook balance of \$29,803.07. Balance at the Vermont Community Fund (VCF): Endowed Fund has \$286,415 and the Reserve Fund has \$50,355.

In terms of the stock market, the fourth quarter of 2018 was bad, but the first quarter of 2019 was good, so there was a net gain.

\$9,500 was awarded in scholarships in May. This was for six scholarships, ranging from \$1,000-\$2,000. For the first time, financial need was used as an additional factor determining amount awarded and a rubric was used that included this metric. The rubric will be adjusted moving forward.

Last year the fund gave out 11 scholarships. This year as there were no graduating Tinmouth seniors from Mill River going to college, the endowed scholarship for a Mill River senior was given directly to the Tinmouth school. The *Susan McIntosh Lloyd Scholarship* and *Robert and Cynthia Johnson Scholarship* were inaugurated this year, both are privately funded.

Asha also gave a summary of the K-12 camp scholarships: \$1,500 was allocated, and three families applied (for a total of nine children). The total requests came to \$1,780, so \$280 was added at the April Board meeting.

\$2,360 was donated to the TCF in Nancy Noble's memory. Board voted that half be put in the TCF and half in the scholarship fund as this was how Nancy usually designated her donations; this will include any future donations in Nancy's name.

#### Capital campaign for the Scholarship Fund

Jan reported that the elements of a capital campaign are included in today's meeting package. Jan gave an overview of the process. First is a feasibility study (meet with current donors and ask for advice). This is a "friendbuilding" activity. Cathy has been working on this. She is creating a package that can be given to potential donors that explains what the campaign is all about. Second is to hire an outside assistant who has experience in capital campaigns. Third is to get the TCF Board excited about the campaign. Non-Board people can also be included who can serve as resources for the campaign. Fourth is to work on a fund-raising strategy and goal (\$100,000). There are also expenses to include, and a deadline to consider for the campaign. Fifth is to develop the case for support - the "why" of the campaign. Who has the Scholarship Fund supported? What have they done with their support? Sixth is the communications strategy (private: meet with potential donors; public: put out publicity).

There was discussion concerning what the capital campaign is going to fund – there is general agreement that this effort is to replace the Plant Sale portion of the Scholarship Fund. Fund-raising will continue for the rest of the Scholarship Fund.

Cathy suggested that we rough out a calendar because it is a multi-step process. Shall we do the regular annual appeal, and then launch the capital campaign at Town Meeting? This would push a five-year fundraising goal to 2025.

Creating a Continuing Education Separate Fund

This needs to be done for bookkeeping purposes to separate the funds at VCF to specify the Continuing Education fund as separate from the TCF. This involves filling out some forms that need to be approved by the Select Board, as well as the TCF Board. Board voted to create a Continuing Education Fund within the VCF.

Cathy recommended that \$28,000 in recently acquired funds (donations and plant sale) be transferred from the checkbook to the endowed fund.

Board voted to instruct the Treasurers to determine the value of the scholarship fund once the second quarter gains are calculated and applied. This will be the opening balance of the new separate Scholarship Fund.

Other business

Cathy discussed the possibilities of writing "stories" to share with the Tinmouth community to recount what past recipients of scholarships are doing now. Nikki volunteered to work on this.

#### Young Wildlife Belong in the Wild

MONTPELIER, Vt. – Watching wildlife is enjoyable, especially when young animals appear in the spring. But it's best to keep your distance. Picking up young wildlife can do more harm than good, according to the Vermont Fish & Wildlife Department. It's also against the law.


When people see young animals alone, they often mistakenly assume these animals are helpless or lost, in trouble or needing to be rescued. Bringing young wildlife into a human environment often results in permanent separation from their mothers and a sad ending for the animal.

Handling wildlife could also pose a threat to the people involved. Wild animals can transmit disease and angry wildlife mothers can pose significant dangers. Department scientists encourage wildlife watchers to respect the behavior of animals in the spring and early summer, and to resist the urge to assist wildlife in ways that may be harmful. Here are some helpful tips:

- Deer and moose nurse their young at different times during the day, and often leave young alone for long periods of time. These animals are not lost. Their mother knows where they are and will return.
- Young birds on the ground may have left their nest, but their parents will still feed them.
- Young animals such as fox and raccoon will often follow their parents. The family of a "wandering" animal searching for food is usually nearby but just out of sight to a person happening upon it.
- Animals that act sick can carry rabies, parasites or other harmful diseases. Do not handle them. Even though they do not show symptoms, healthy-looking raccoons, foxes, skunks, and bats also may also be carriers of the deadly rabies virus.
- Many wildlife species will not feed or care for their young when people are close by. Obey signs that restrict access to wildlife nesting areas, including hiking trails that may be temporarily closed.
- Keep domestic pets indoors, leashed or fenced in. Dogs and cats kill many baby animals each year.
- Avoid projects that remove trees, shrubs and dead snags that contain nests during the spring and summer.

For information about rabies and nuisance wildlife, call the Vermont Rabies Hotline at 1-800-4RABIES (1-800-472-2437). If bitten or in contact with a raccoon, fox, skunk, or bat, or a domestic animal that has been in contact with one of these species, call the Vermont Department of Health at 1-800-640-4374.



Ticks are EVERYWHERE!! Below you will find some of tips, recommended by the VT Department of Health for staying healthy during this "tick season"!

### **Tips for Preventing Lyme Disease**

• If hiking, stay on cleared trails – ticks often live in areas of tall grass and brush


• If possible, wear light colored clothing that covers arms and legs

(pants/ long sleeves) and tuck pant legs into your socks.

- Apply insect repellents to exposed skin areas before you go into areas where you may be exposed to ticks. Use

- <u>Most importantly</u>, check yourself, your children, and your pets DAILY for ticks and remove them carefully with a tick remover (available at local drug stores, doctors offices, veterinary offices, and pet stores for only a few dollars).
