## ~ Town Meeting 2021 ~

Will be a little different this year. Due to the corona virus pandemic, the Legislature granted authority to the Select Board to conduct town meeting business using the Australian balloting system. As Town Meeting from the floor will not meet state guidelines for public gatherings, the Select Board decided to use that authority for 2021.

We will elect officers as well as vote on budgets and public questions this way. There will be an informational meeting – held via Zoom or similar virtual format on Saturday, February 27<sup>th</sup>. Voting will be by Australian balloting at the Old Fire House on Tuesday, March 2<sup>nd</sup>.

**You are encouraged to vote early/absentee. You can call the town office to request the ballots.**

Town Meeting will find voters choosing the following officers:

- Moderator - Town - 1 year term
- Select Board Member - 3 year term
- Road Commissioner – 3 year term
- Lister - 3 year term
- Auditor - 3 year term
- Tax Collector (Delinquent) - 1 year term

Stan Wilbur has announced that he will not be running for re-election as Moderator. Anyone interested?

The Legislature also (for 2021) removed the requirement to get signatures for a petition to run for an office. If you wish to run, you only need to file a consent form, available at the town office, with the town clerk by 5:00 PM Monday, **January 25<sup>th</sup>**.

## ~ Early/Absentee Ballots ~

Due to the continuing presence of the corona virus pandemic, please vote early/absentee if you can. This provides a bit of safety for voters and poll workers. Nearly 75% of votes cast in November were early/absentee!! The polls will be open at the Old Fire House on March 2<sup>nd</sup>.

To request an **Absentee Ballot**, you must do so before **5:00 pm on Monday, March 1<sup>st</sup>**. **Voted ballots must be returned by 7:00 p.m. on Tuesday, March 2<sup>nd</sup>**. You can also vote **early** at the town office starting mid-February.

*Tales of Tinmouth* is mailed monthly to 540 households ~ residents, property owners, past residents, and friends. It is a bit dismaying that only 80 or so of those contribute to help pay for paper, printing, labels and postage – those expenses are over \$3,000 per year. The Town allows the use of their copier, but is reimbursed for all copies made. And we thank them for use of the town office for assembly space. There are dedicated volunteers who gather each month to fold, tape and label. No one is paid.

~ Covid 19 Update ~

The good news is that we have learned a lot about how to safely navigate the Covid world. We know how to judge the relative risks involved in our daily activities and what behaviors help to reduce those risks. In fact, thanks to the adherence of the majority of Vermonters to the suggested safety measures spelled out by our governor and related state agencies, Vermont enjoyed the reputation of being the safest state to live in during much of the past year. These results speak for themselves and negate the contrarian propaganda by those who would try to convince us to do otherwise for their own perceived benefit. This misinformation has led some of us astray. That is the reason why the US, with only four percent of the world's population, suffers twenty five percent of the worlds fatalities linked to this disease. That fact says it all. Constitutional rights do not necessarily trump our social and moral responsibility to protect others.

On the flip side, living with the virus has often changed our behaviors and altered our values for the better. Many have become more thrifty, self-reliant, organized, creative, and prepared. Also many have become more aware of the value of friendships, social responsibility, organization and altruism. It's brought out the best in many of us. Crisis situations provoke change and often that is for the better.

*On the practical side I have these suggestions.*

If the readers find themselves in crisis please make use of systems that are available. Vermont's 211 phone and online crisis hot line is a fountain of information with linkage to help of all sorts. When I've been involved in state emergency drills the 211 number was my main help line for most all contingencies. It covers community resources, health care options, public assistance, training and employment opportunities, food acquirement, mental health assistance and the list goes on.

Secondly feel free to link to the Vermont Health Department's web site. This centers on health safety and resource availability. Questions about testing, and vaccine availability are here. I've recently subscribed to the Vermont Alert system via a link on this page. Vermont Alert has been developed to warn the individual citizen of any emergency situation developing in real time in their immediate area. It's a little complicated to join but if I could do it, being the techno-dinosaur that I am, I think most people can.

Thirdly I'd suggest that you follow the Governor's noontime press conferences on VPR. This will keep your understanding of the situation sharp and up to date. We are so fortunate to have a governor who has followed science and factual information to form a practical response to the Covid monster. A strong majority of my fellow Vermonters agreed with this approach by re-

electing republican Governor Scott despite his spending none of his time campaigning for office.

Finally, I have to note that the overall situation is going to get worse before it gets better. We all have to double down on our protective behavior. I know what a pain it is. I miss the close contact of my extended family and friends but that is nothing compared to how I would feel if I found myself to be the vector of their infection. Hopefully the spreaders will return to the fold, wear a mask and care about the rest of us. If they do please don't make an issue out of their change of heart. Just silently accept them back into our compassionate fraternity.

**STATEMENT FROM GOVERNOR PHIL  
SCOTT ON THE FDA APPROVAL OF THE  
PFIZER-BIONTECH VACCINE FOR COVID-19**

Montpelier, Vt. – Governor Phil Scott issued the following statement:

“I join many across Vermont and the country in welcoming news of the first approved vaccine for COVID-19. This is an important milestone and a major – and essential - step toward defeating a virus that's having devastating impacts on families and businesses throughout Vermont and around the globe.

“I want all Vermonters to know we've had a team of talented experts working for months to prepare for what will be an unprecedented effort to deliver safe and effective coronavirus vaccines. The process will be difficult, and we are ready. My Administration will focus first on protecting the most vulnerable and those at greatest risk during this crisis, which is why we will begin our rollout by vaccinating nursing home staff and residents, and those treating and interacting with COVID patients throughout our healthcare system.

“There is no better, safer or faster way to defeat this virus and work to rebuild our economy than a successful effort to make vaccines available to every single Vermonter. We are committed to working with our partners to get this done, so we can get through this and be stronger and more resilient than ever before.

“This is a significant step forward, but we still have months of discipline and hard work ahead of us. Until enough people are vaccinated, it is critical we remain vigilant. So, I urge all Vermonters to continue wearing a mask in public, keeping six feet apart, avoiding crowds and gatherings and quarantining when required. Together, we can keep each other safe as we work our way towards the end of the tunnel.”

Fire Departments all over the country are grappling with the effects of the Pandemic on how they operate. The Tinmouth Volunteer Fire Department is having to adapt with this new threat as well. Like many other Fire Departments large and small we are now meeting remotely and training virtually with training videos and discussions to remain as ready as possible. How we fundraise has also changed and we may not be able to host our famous Tinmouth Game Supper as we have.

Slow rollout of the vaccine and not all willing to take it poses new approaches to how we operate for an unknown period. Hopefully most people in the greater community who are considered high risk will be vaccinated but even some of those considered high risk are declining to be vaccinated. Some members of the Fire Department are also declining at this time. This is all personal choice for different reasons and will be respected within and without our department.

As a First Responder our first responsibility is to do no harm in our efforts to help others. Considering all of this we do not want to put at greater risk anyone that we may be trying to help. If you are a person that is considered high risk please contact Chief Marshall Squier: 235-2718 or Sherry Johnson: 446-3307. This information remains within the department to help us identify and make changes in our response so we do not further compromise anyone's safety. If your situation changes please let us know as well.

Adapting to these changes requires us to keep safety for all in mind within our department and our department has adopted mask wearing and social distancing to the best of our abilities as most other department have also done. As an ALL VOLUNTEER Fire Department we appreciate all community members doing their part in respecting these necessary changes.

Part of this as community members would be being as proactive as possible. Check and update fire detectors, have fire extinguishers on all floors of the home and in the kitchen, keep chimneys clean and debris and furniture away from wood stoves. Call Fire Warden Glenn Merrill 446-2782 or Assistant Fire Warden Wheaton Squier: 446-2082 for outdoor burn permits.

It is illegal to burn outdoors without a permit unless there is snow on the ground. However, spring and fall are the highest risk for brush fire so do not burn without permits please.

As Chief, I would like to thank every Fireman past and present who have given and continue to give a part of their

lives to help others. These members are all exemplary people and the personal satisfaction in helping others and heartfelt gratitude expressed by community members is our only pay.

If you are high risk for COVID-19, the Tinmouth Volunteer Fire Department needs to know so we can respond appropriately and minimize any additional risk.

~ **Checking on Neighbors** ~

If you live by yourself, or don't have family or friends checking on you daily, it might be a good idea to think about finding someone to help with that. A recent incident in town occurred when concerned neighbors had to call the Vermont State Police for a welfare check as they noticed no tracks in or out of the house or garage, mail and newspapers were piling up, and no one responded to the telephone, or knocking on the door.

Neighbors had no one to contact. It turned out that the person had been picked up by a nephew from another state for a visit through the holidays. The VSP had to break a window in the door to enter, they found no one there, and the house was secured upon their departure. But several neighbors and others were quite concerned with this elder's wellbeing.

If you have a neighbor who fits this description, please think about reaching out to see if you can help. If they need a hand, or are going to be away, have them give you a call before they go.

Cathy Reynolds was elected to the Select Board. Marian Ackerman was elected to the School Board,

Winter snowfall was reminiscent of the “old days”! The Select Board named all town roads and private drives as part of the “locatable addressing” for 911.

The Select Board adopted a Trash Ordinance that banned burn barrels.

The Town bought a one-ton dump truck. The Town began work on re-claiming old cemeteries in town. The Crampton Cemetery was the first.

The Town sold its remote parcel of land, work on property maps will begin soon with the proceeds.

We do a great job recycling – more items are added! The Tinmouth Volunteer Fire Department celebrated its 25<sup>th</sup> anniversary. The 25<sup>th</sup> Game Supper was also held.

The Fire Department hosts its annual Halloween Party for town children of all ages!! The Spook Walk is GREAT!

The Fire Department purchased a radio to help the Wallingford Rescue Squad locate folks faster.

~ Meeting Highlights ~

(Complete minutes are available at the town office.)

Select Board ~ 12/10/20

Present were members Michael Fallar, Cathy Reynolds, and Frank Sears, as well as Eric Buffum – Road Commissioner, Stan Wilbur – Public Works Project Manager, Sherry Johnson, Kim Harbaugh, Craig Jewett – Engineer with Otter Creek Engineering (OCE), Grant Reynolds, Ronnie Crossman, (Doug Fontein and Rainbow Squier - Conservation Commission at 8:50) and Gail Fallar – Select Board Assistant (SBA).

Minutes of 11/24/20 were approved with correction to remove a comment attributed to Eric Buffum regarding the design/build proposal and a reference to Snow Mountain Lane, Board voted to accept as corrected.

Highway ~

Eric reported business as usual, working on snow fencing.

Winter Salt Bids were opened.

Requests were for 1) regular rock salt and 2) deicer salt product.

Eric advised that the deicer product from Apalachee works better as it has a higher sugar content, is more efficient, is less corrosive, that they are the current vendor and service has been great. After brief discussion, Board voted to accept the Apalachee bid (more expensive but more efficient and less corrosive).

Better Roads Grant Application – After brief discussion, Board voted to approve application for culvert on Potter’s Brook on North End Road (used same info used for VTRANS grant that is on hold).

‘What If Plan’ – Eric advised that he had contacted Glenn Merrill and Marshall Squier for back-up for snow plowing, still working on the plan. Board asked for a mark-up for the next meeting.

Second December SB Meeting – Board decided move its December 22nd meeting to January 7th.

Public Works Facilities ~

Stan advised that he anticipated the design/build proposals would be returned in time for the Board to review on the 7th. He also advised the state had confirmed that no storm water permit is needed for the garage project.

Craig (OCE) advised that he had confirmed with the state that under certain conditions no storm water permit would be required. He will send a marked-up plan to Stan, still working on it as there is about 950 square feet over the one acre maximum – trying to eliminate that with other places on site or squeeze the size of the garage. He advised that the town still needs to make a formal determination on how to proceed – there is no time frame,

but the state has a 60 day window before considering it dead. The Town would have to re-start the permit process.

Craig advised he will get the design related changes and plan to Stan next week, Board asked that he share it with Eric and Ronnie to make sure it will work. Board asked whether work done for salt/sand shed will be lost, Craig advised barring any changes it will be alright to use, permit will only be needed for that facility. Permit fee may need to be paid again, but with less impervious surface the fee will be less. Board inquired about the time frame – it’s been a over a year now – Craig replied 30-45 days with a 45 day state review period – should use six months to be on the safe side.

Craig also advised that building on the existing impervious areas doesn’t require a permit, nor does re-developing an already impervious site. The sand and gravel stock piles are considered pervious as they can be moved. Craig also clarified that once the permit is issued, it does not have an expiration date.

Design/Build RFP – Board reviewed draft, asked Stan to clarify that the four bay proposal was a starting place that the Board had determined was not viable, and add that current energy standards have to be met. Added two more firms to list of contractors to solicit bids from – there are now nine. Board agreed to have Stan proceed with sending out the RFP. Stan noted he expected to receive the proposals on the 4th and to prepare packets for the Board to discuss at their meeting on the 7th with interviews of prospective contractors at the Board meeting on the 14th. Stan and Craig left the meeting at this point.

Personnel Policy Update - Board discussed: proposed changes, additions due to Covid19 restrictions, difficulties with those with a crew of two, is the road crew essential workers (yes), how to keep them safe, etc. Cathy volunteered to continue work on proposed changes.

One proposed change would the reduce accumulation of vacation days from 15 to 10 – Eric raised concerns with forfeiting that, asked if road crew could be paid for unused vacation days. Ronnie noted that when he is away fighting forest fires he is not on vacation (but is on vacation from the town) and is working as an emergency first responder.

Board members expressed concern for a crew of two taking vacations (in the summer as they are not allowed to do that during the winter), how to manage that, and the need to think about how to support employees.

Health Insurance benefits were discussed, the PP needs to be less specific regarding which plan, use more general language. Board voted to remove PPC comments and update the current Personnel Policy information to reflect the Silver Reflective Plan.

Health Insurance for 2021, after brief discussion, switching to MVP for the same plan (as BCBS) – Silver Reflective Standard, would save \$2,484. Road crew



approved. Board voted to approve switch from BCBS to MVP for the road crew.

**Draft #1 FY22 Highway Budget** – 3% raise for road crew, discussed increase to roadside mowing, winter sand, decided to keep equipment fund allotment the same to help keep tax rate from wild fluctuations, discussed how to allot the increase in FY21 to state highway aide (one time action) – inclination is to add it to the Capital Building Fund.

**Draft #1 FY22 General Budget** – Added stipend for Emergency Management Director and Coordinator. Discussed whether to continue with the transfer station or hire a company to pick-up the entire town – need some research done in that regards.

**Conservation Commission** – On behalf of the Conservation Commission, Doug and Rainbow reviewed possible uses for the town’s property behind the town garage – long term and short term, to encourage recreation and enjoy nature – trails, fruit trees, frisbee golf course, picnic tables, community garden, volleyball court, pickle ball court, horse shoe court, to name a few. Board took under advisement and asked CC to return in January.

**Financial** ~

**Financial Report** – Board voted to accept.

**Warrants Reviewed** ~ Payroll Warrants #21 dated 11/23/20 for \$1,409.92, #22 dated 11/30/20 for \$3050.72, and #23 dated 12/7/20 for \$2019.73; and Accounts Payable Warrant #9 dated 11/23/20 for \$11,859.72, and #10 dated 11/30/20 for \$6,803.05 were reviewed. Board voted to approve.

**2020 Property Tax Waiver of Penalty and Interest** –

Gail advised that the Legislature had given the Select Board authority until January 1<sup>st</sup> to waive interest and/penalty on property taxes. After brief discussion, Board voted to create a six month grace period beginning November 17<sup>th</sup> where no penalty or interest would be assessed for 2020 property taxes.

**Old Business** ~

**Trash and Dogs at 605 Mountain View** – Frank reported on his conversation with attorney Jim Carroll. If there is a health hazard the Board is required to act. There are two tracks that can run at the same time, violation of the Solid Waste Ordinance and the health and safety statutes. Both could end up in court. Frank as Health Officer and Solid Waste Enforcement Officer will have to recuse himself from the Select Board during a hearing or any action taken. Board reviewed complaint from neighbor and will respond, noting it has been an ongoing problem for a number of years. Will take action at its January 7<sup>th</sup> meeting.

**New Business** ~

**‘What If Plan’** – Still being worked on for town office functions. Board asked Gail commit to also preparing a written procedure for all functions of the clerk/treasurer.

**Holiday Bonus** – Board discussed \$100 bonus for road crew, transfer station attendants and town office staff. Board voted in favor (Michael recused himself re:Gail’s bonus).

**911 Re-numbering for Tinmouth Pond Road** – Gail, as 911 Coordinator, reported the 911 Board requested that Tinmouth Pond Road be re-numbered due to confusion with Danby’s numbering system on the south side of the road and Tinmouth’s on the north side. Tinmouth’s increment is 50 feet, Danby’s is 5.28 feet – the standard now used. 50 feet was the standard when original 911 numbering was done in the 1990’s. Board voted to re-number Tinmouth Pond Road.

**Highway Aide Allocation** - Board decided to add the allocation of the extra highway state aide to the January 7<sup>th</sup> agenda.

**Town Meeting 2021** – After brief discussion and due to the pandemic, Board voted to switch the floor portion of 2021 town meeting to Australian ballot. This includes voting for the budgets and any public questions. A virtual informational meeting will be held on Saturday, February 27<sup>th</sup>.

Gail advised that the Legislature eliminated the position of Town Agent and made Grand Juror an appointable position – no longer elected. Board voted to remove these offices from the town meeting warning.

Dear Valued Customer,

For many years, your home phone would allow you to stay connected to emergency voice services during a power outage. However, many of today's advanced home phone services, such as VTel's, require backup power to continue functioning during an electrical outage. Without a backup battery or alternate backup electrical source, such as a generator, customers will not be able to make any calls, including emergency calls to 911, during a power outage.

To avoid a disruption of home voice service during an outage-and to maintain the customer's ability to connect to 911 emergency services-VTel installs a battery backup power unit, including a battery, when we convert a home to VTel's fiber optic network. When first installed, this backup battery typically lasts approximately 8 hours during an outage (which is the length of time the battery is powering your Optical Network Terminal (ONT), not the time you spend using your phone).

Environmental factors such as temperature may shorten a battery's useful life. Batteries should be kept in dry conditions, operated within a temperature range of 32-104°F (recommended operating temperature range) and stored within a temperature range of 5-113° F (recommended storage temperature range). Aged batteries require replacement. Batteries typically last 3-5 years under normal conditions. Replacement is the sole responsibility of the customer. Specifications for replacement batteries purchased by customers may vary.

In order to preserve the life of the battery, VTel encourages all customers to review the additional battery backup information, including purchasing resources and step-by-step instructions for battery replacement and for connecting 20-hour EBPs, on our website at <https://www.vermontel.com/about/fiber/battery-information>.
