~ Homestead Declaration ~

This a reminder that you need to file an **annual** Homestead Declaration with the Vermont Department of Taxes, form HS-122. You must file this to qualify for the homestead education tax rate and to request a **property tax adjustment** if you are eligible. You must also file form HI-144 (household income), **due April 15**th. This is required even if you do not have to file or pay state income taxes.



~ Dog Licenses Due April 1st ~

A current rabies certificate is required. You can call the Town Office (446-2498) if you don't know if your dog needs a shot or not. Fees are \$9 for neutered/spayed dogs and \$13 for those that are not. 50% penalty is assessed after April 1st.

To the Tinmouth Community,

February has traditionally been a quiet month, and this year it's been unusually quiet. We couldn't participate in our winter sports program due to the pandemic restrictions. Under normal circumstances, this program runs through February. It's a favorite of students and gets everyone outside during the doldrums of winter. This program is essential for students in order to develop and hone their skiing, snowboarding, and skating skills.

However, we have been gearing up for next year and I mean that literally! We received a grant from the Tinmouth Community Fund last spring and purchased harnesses, ropes, and carabiners needed to use the climbing wall in the Community Center. Over the summer, we're hoping to recruit a few volunteers to caulk and replace footholds on the wall. The wall will be back in use by September 2021.

We also received a grant from the Vermont Principals Association for \$3,500. The grant was requested to fund snowshoes for classes currently participating in the Fish and Wildlife's Scat and Track program. It was a challenge finding snowshoes since our local New England stores are completely out of stock. Red Feather Snowshoes in Wisconsin provided us with a school discount that allowed us to purchase snowshoes for every student from pre-K to sixth grade. Perhaps the snow will melt before they arrive but we will be ready for our next snowfall and tracking expedition!

Additionally, the students are now sledding on the incline between the school and the church. Up until the beginning of February, they were prohibited from sledding because there weren't enough sleds to assign to each student in a class and then disinfect as a precautionary measure. This is no longer the case, and here's why: At the start of February, I stopped by Poultney Pools & Hardware to see if there were any sleds available. I was surprised that there were nine left so late in the season. I was mentally computing the total cost to be sure I could cover the expense as I brought the sleds to the counter to purchase. As the gentleman behind the counter handed me a receipt, he told me he was donating the sleds to the school! I was truly surprised at this random act of kindness! Needless to say, the children were delighted!

Academically, the students are working hard on catching up in reading and math. Remote learning is a stopgap but certainly not a substitute for in-person schooling. Teachers are tutoring students in homework club from 2:00 to 3:00 p.m. on Mondays, Tuesdays, and Thursdays. We have implemented a Read Every Day program where students set their own goals, which include reading a specific number of pages each month. Additional district staff members have been working with students who struggle with reading and math concepts.

Overall, the students are taking advantage of February's snowstorms by sledding and a new sport we call "snow-swimming." Everyone is working hard to cover academic ground lost in the early months of 2020 when we were forced into remote learning. Teachers and students are looking forward to the spring when we can continue our studies in outdoor classrooms

I'm excited to announce that the Rutland Free Library is offering a new program to children in our town – Dolly Parton's Imagination Library. Dolly Parton's Imagination Library is a book gifting program that mails free, high-quality age-appropriate books to children from birth until age five. Each month, the Imagination Library mails a book directly to all registered children, addressed to them, at no cost to the child's family. Dolly Parton's Imagination Library has gifted over 152 million free books to children since its launch in 1995; it gifts a book to a child once every 2 seconds!

FAQs

After I register, when will my child start receiving books?

~ Tinmouth Community Grant Awardees ~

This year the Tinmouth Community Fund continued funding worthy projects that make Tinmouth a better place. The variety of proposals illustrates the creativity of the people of Tinmouth, and the care they take of our community. The 2021 awardees each received a \$500 grant. The awardees are:

- **Tinmouth Directory Committee**, to produce an updated version of the Directory, which is a most useful community resource.
- Old Creamery Committee, to continue the restoration of this historic building in the center of town. The plan for this year is to extend electricity to the building, build a ramp, and repair and paint two of the exterior walls.
- *Tales of Tinmouth*, to continue to keep the community informed on a monthly basis about what's happening in town.
- Tinmouth Pond Milfoil Project, to continue its mission to conduct an effective management, prevention, and educational program around invasive aquatic species.
- Be Seen in Tinmouth, to purchase reflective gear for the safety of people and animals who use town roads for exercise and the enjoyment of our beautiful surroundings.
- **Tinmouth Mountain School** for materials for a composting workshop where students will learn how to build worm composting bins and make an educational video so that they can teach others how to make their own composting bins.
- Tinmouth Plant Sale for the development of a watering system for the new and improved Plant Sale. This will allow for a longer-duration Plant Sale, thus bringing in more revenue, as well as preserving the lower backs of Plant Sale volunteers who will no longer need to haul hoses around.
- Tinmouth Elves, to purchase toys and warm clothing for children whose families qualify for holiday food baskets. This past year has only emphasized that there is need in our community, and we are grateful to the many volunteers and donations that makes this holiday effort such a success.
- Tinmouth Walking Club, to create a booklet showing the roads, routes, loops and trails in town, to encourage health and fitness and connection to Tinmouth. (This award was inadvertently left off the list of awardees at the TCF annual meeting; the secretary apologizes!)

TCF also awarded two small business grants – for those looking for assistance to launch or enhance a small business in Tinmouth.

Tom Foolery Jewelry (business startup) and Vermont Mountain Meadows Farm (assistance to install a walk-in cooler to enhance produce sales) both received grants.

The TCF is offering a second opportunity in 2021 to apply for both Community Fund Grants and Small Business Grants. We will be awarding an additional \$5,000 in grants up to \$500 each. Applications are due May 1.

Congratulations to all the organizations and businesses that wrote grants. Would you consider writing one? Do you have a good idea about how to make Tinmouth a better place? Create a new opportunity in Town? We now have the grant application as a fillable form – it is very easy to apply, and any TCF Board member would be happy to walk you through the application process and answer any questi~.

~ Meeting Highlights ~

(Complete minutes are available at the town office.)

Select Board ~ 2/11/21

Present were members Michael Fallar, Cathy Reynolds, and Frank Sears, as well as Stan Wilbur – Public Works Project Manager, Eric Buffum – Road Commissioner, Ronnie Crossman, and Gail Fallar – Select Board Assistant (SBA). (Sherry Johnson, Kim Harbaugh, and Meadow Squier at 7:00)

The Board entered Executive Session at 6:30 for the purpose of discussing potential contract negotiations, where premature general public knowledge would be detrimental to the interests of the town, and included Stan, Eric, Ron and Gail. Board exited Executive Session at 6:46. Frank noted the Board considered proposals from Morton Buildings, Giancola Construction and Wright Construction. Board voted to choose Morton Buildings as the contractor for the design/build of the town garage. Next step is for Stan to contact Morton to request a draft contract for be reviewed by the Board and legal folks. Frank volunteered to write a letter from the SB to the competitors thanking them for their participation.

7:00 – Sherry, Kim and Meadow joined the meeting. **Highway** ~

Eric reported lots of plowing, sanding and salting. Orange tandem truck was down due to an antifreeze leak, back on line now. Eric inquired about direct deposit for payroll. Gail reported it would cost in excess of \$600 per year, basically the town would not receive any interest on its general fund checking account due to bank fees for the service being netted against earnings credit (not interest) which would result in the bank charging the town if the fees were more than then earnings credit and keeping the earnings credit if those were in town's favor. She advised against it for just two employees. Board concurred and inquired if the employees could deposit their checks with their cell phones – they will look into that.

'What If Plan' – Eric advised he is still working on it. Board asked that it be presented at its February 23rd meeting.

Emerald Ash Borer – Eric noted he is still working on getting an estimate for ash tree removal. Board discussed recent education piece written by the Conservation Commission and the Tree Warden advising folks about the situation and what to do/not do. No action needed by the Select Board. Board noted receipt and expressed appreciation for their efforts.

Board discussed process to determine/prioritize which trees needed to be removed first – Eric suggested working on them in loops – such as McNamara Road, Gulf Road and Route 140 between those two. More efficient to keep work crews in one place to make one mess at a time. Board asked Eric to compile a list of the loops, prioritize by number of trees, traffic, importance of which to cut

first, etc. Eric noted he will ask Tree Warden David Birdsall to assist.

Road Commissioner Job Description- Postponed to the 23rd, needs small adjustment to address a transition plan if there is a change in personnel.

Community Concerns – *Shirley Bucceri* emailed request regarding snow banks at the end of North End Road where one turns right onto Route 140. Eric noted there is no place to put the snow, that section of the intersection gets plowed after regular plowing is done, and that there is room to safely turn. After discussion, Board asked the road crew to use the loader to move or remove it. There is excess snow on other roads that have been addressed as well.

Theresa Butts emailed questions about cleaning roads edges on a Saturday (needed to be done before snow on Sunday), narrow roads (no place for the snow to go, same as they've always been), and the grader was winging snow away from the roads, (trucks can only push the snow so far).

Cathy, as a private citizen, expressed appreciation for the road crew getting up early so folks can make it to work; there is more work than two can do, and they are doing the best they can.

Board discussed the need for better communications regarding road conditions and limitations, Frank volunteered to write a posting for Front Porch Forum. Eric also noted that the road crew cannot plan any vacation time or get-aways during the winter as they need to be around in case of a snow storm. Cathy moved that the Select Board write a letter of support and appreciation for the road crew, Frank 2nded. Cathy and Frank voted in favor, Michael voted no. Motion carried.

Financial Report – After discussion about revenues and equipment rent, Board voted to accept.

Trash at 605Mountain View – Board agreed to speak with attorney Jim Carroll on the 23rd.

72 Snow Mountain Lane – Frank, as Health Officer, advised that Howard and Deb Buffum had again asked the town for assistance with trash in one of their tenant properties. He asked the Board's permission to take a look and report back. Permission granted.

Personnel Policy Review – Moved to March 11th Board meeting, will ask road crew for input.

'HWY What If Plan' – Moved to meeting on the 23rd.

Frank advised that he wanted to revisit the proposal from Meadow Squier at the Board's January 14th meeting. He noted he had received remarks from the community that caused him to reconsider. He felt at the time that the Board should speak unanimously, but has changed his mind on that. He was also uncomfortable with reference to the Legislature's Resolution as he did not have it in hand – and having researched it was still uncomfortable with that part.

Michael noted he had also received community comments which were not comfortable with the proposed language, felt that it was a political position that the Town's Personnel Policy discouraged, and suggested voters should have a chance vote on it.

Meadow responded that it was not a political statement, that it dealt with a specific violent event trying to stop the transfer of power. She proposed it be re-worded to remove the reference to the state legislature; "We the democratically elected officials of the town of Tinmouth condemn the violent attack of January 6th on our nation's capital and our democracy. We trust that our community will work together to resist this violence and uphold the democracy that makes our nation great." Cathy moved adopt amended resolution, Frank 2nded, both voted yes, Michael voted no.

Sherry noted that the violence on January 6th was a brutal and vicious attack on our democracy.

Personnel Review - Board moved it to March 11th, as the Personnel Policy calls for an annual review, but it has been difficult in the past, Board needs to think about how to conduct it.

2019 and 2020 Grand Lists - After brief discussion, Board voted to sign and seal the 2019 and 2020 Grand Lists as there are no appeals or suits pending.

RRPC – **LHMP** Contract – After brief discussion, Board voted to approve amendment to the contract with Rutland Regional Planning Commission for updating the Local Hazard Mitigation Plan due to time constraints, and to authorized Michael to sign it.

Members Concerns – Cathy expressed concern with the Select Board not receiving its mail. Amy Martone, MRUUSD representative, had sent a letter of resignation that the Select Board did not receive. Gail, as SBA, gets the SB's mail – need to have a discussion about the process.

Mail/Correspondence – Gail advised that the Vermont League of Cities and Towns had sent a report called "Community Leadership in Action" for the Board to review either at the town office or online. Other correspondence (Bucceri; Butts; Johnson/Harbaugh) was acted on earlier in the meeting.

Select Board $\sim 2/23/21$

Present were members Michael Fallar, Cathy Reynolds, and Frank Sears, as well as Jim Carroll, Esq. 6:30-7:00, and Gail Fallar – Select Board Assistant. (Stan Wilbur – Public Works Project Manager, David Birdsall, Sherry Johnson, Kim Harbaugh, Grant Reynolds, and Meadow Squier at 7:00) (Doug Fontein from 7:42 until 8:05)

Frank called the meeting to order at 6:30. Board voted premature disclosure of attornev/client communication involving legal advice relative to possible enforcement action under the Solid Waste Ordinance and public health statutes, would leave the Town at a substantial disadvantage. Board then voted to enter executive session to discuss attorney/client communications relating to legal services concerning potential enforcement actions under the Town of Tinmouth Solid Waste Ordinance and public health statutes with attorney James Carroll and Gail Fallar invited to attend. Board exited Executive Session at 7:00. No action taken.

Frank called regular portion to order at 7:09, welcomed all. Board reviewed agenda; excused the road commissioner as he was unable to attend due to road work, added Sullivan & Powers audit agreement letter, political sign question, and Tinmouth Pond Milfoil Project grant request; and postponed the Personnel Policy and "What If" plans discussion to March 11th.

Minutes: Minutes of 2/11/21, after brief discussion Board decided to have the SBA transcribe Meadow Squier's statement from the meeting and have the minutes read, "Meadow said . . .", approved as thus corrected.

Public Works Facilities Update ~ Stan presented draft contract from Morton Buildings, noting only page one (for the design/build work) needed approval. The other 9 pages were a projected town garage — a starting place to work from. He asked the Board to authorize Frank to sign. Board noted that the amount of the building should be \$500,000, not \$500,000-\$550,000. Cathy noted that the proposed design WAY did <u>not</u> meet the energy code. After discussion, Board voted to accept with revision to the amount and authorized Frank to sign page one for the Board. Stan will contact Morton regarding the changes and request a clean copy before Frank signs. Cathy will drop off the State's energy code for Stan to review.

Stan also provided an update regarding costs for the town garage project, included no costs for salt/sand shed. As Morton won't be starting until July, there is no hurry for the site work to be done, and the ground needs to thaw as well. Site work may/will need larger equipment than the town owns.

Stan reported the State Storm Water permit is still being discussed by the OCE engineer and state reviewer.

Highway ~

No Eric, road crew on duty.

Stan advised that the Board should consider doing away with an elected road commissioner, appoint one who reports to the Board and hire a road foreman to do the road work. Board took under advisement.

Emerald Ash Borer ~ David, as Town Tree Warden, noted that the town should have a plan, there is a need to get the word out to land owners to raise awareness about what is going to happen, concerns with safety, etc. It was suggested that the Conservation Commission might help, so Doug Fontein, Chair, briefly joined the meeting. After discussion of the need to pull together information from other towns as to what they are doing; what the road crew may or may not be able to do; whether a team of local loggers (Dave, Mo Squier and Wheaton Squier) could become town employees for the purpose of cutting down trees (need to check with insurance company); the need to development a multi-year budget for ash tree removal; the need to prioritize which trees or road loops; whether to drop and leave in the woods; the need for a plan; whether Green Mountain Power or VTEL will cut trees in their right-of-ways; and flagging the priority trees; David volunteered to meet with the road commissioner and have a pow-wow to work on a time line.

Road Commissioner Job Description ~ Cathy moved to replace "retiring" with "current", Frank 2nded. Michael noted that the sentence concerning the job starting sometime before April 15th needed to be removed as the election is effective immediately. Frank noted that further work on the job description would continue in the future. Cathy and Frank voted yes, Michael voted no. Motion passed.

Other ~ David advised that he is working on a boundary adjustment with a neighbor, but that there are delinquent taxes due. He requested the town (SB and delinquent tax collector) agree to pro-rate the amount due on the .6 of an acre. Board approved the concept as long as it is legal.

Financial ~

Financial Report – Board voted to accept as presented.

Warrants/Orders ~ Payroll Warrants #33 dated 2/15/21 for \$1,780.92, and #34 dated 2/22/21 for \$2,876.52; and Accounts Payable Warrant #16 dated 2/22/21 for \$29,245.99, were reviewed and approved.

Michael noted that Ronnie had worked the Friday after the last meeting removing the snow at the intersection of Route 140 and North End Road.

Gail presented the **engagement letter for audit services** from Sullivan and Powers – dated July 28, 2020, but just received by the town. Board vote to accept and authorize Michael to sign.

Old Business ~

Trash at 605Mountain View — Board voted that the Select Board authorize the Town Health Officer (THO) to proceed with judicial action against Ron and Jennifer Hill per Title 18, Section 126 — THO and County Sheriff will issue a citation regarding violation of the Solid Waste Ordinance and conduct an inspection re:health hazards.

72 Snow Mountain Lane – No report.

Frank advised that he will be retiring as the THO on June 30, is willing to train someone.

'Town What If Plan' - Gail advised that progress is being made, with notes from former bookkeeper Kim Young.

New Business ~

Town Meeting Prep ~ Board discussed virtual concerns – how will someone ask a question, etc. Board will ask Stan Wilbur to provide an update on the town garage project, asked the SBA to invite local state representatives to speak briefly, agreed to log on at 12:45 to help work out any kinks.

TD Bank Signature Cards ~ Treasurer advised that two signatures are required for all accounts, a couple established in the last year have only one, Board voted to add second person on the Record Preservation/ Restoration account as well as the TCF Continuing Ed Scholarship Fund, and that the TCF Treasurer be the 2nd signer on the TCF and TCFCESF accounts.

TPMP ~ Gail requested on behalf of the Tinmouth Pond Milfoil Project, that the Board approve application for an Aquatic Nuisance Grant to help control milfoil in Tinmouth Pond. Board voted to support the TPMP's grant application for milfoil mitigation.

Political Signs on Town Property ~ Cathy advised that political signs needed permission from landowners to be posted, and that there were a couple on town property but the town had not been asked. Michael moved and Frank 2nded, that permission be given for this year (election is only a week away) and that the SB adopt a policy for next year. Frank and Michael voted yes, Cathy voted no. Motion passed.

Members Concerns – Cathy asked that the Personnel Policy be read by all employees before the SB meeting on 3/11 where it will be discussed.

Frank advised that he was working on a job description for Select Board members – hopes to have it ready for 3/11 or 3/23.

Tinmouth Community Fund ~ 2/18/21 Zoom Meeting due to Covid-19 restrictions

Present were Committee members Jan Krantz (Chair), Cathy Reynolds (Treasurer), Casey Voigtlaender, Todd Dennis, Asha Carroll, Lisa Patry, Melody Squier and Helen Mango (Secretary), as well as Gail Fallar.

Cathy reported that the TCF had met its \$100,000 capital campaign fund-raising goal set at last year's annual

meeting, thanks in large part to an anonymous \$52,000 donation. Cathy then gave a summary of TCF finances:

As of 12/31/20, the Continuing Education fund had a balance of \$310,558.99, the Endowed Fund had a balance of \$143,379, and the Reserve balance was \$59,632 (this is money that can be used for larger projects).

Because the TCF is sponsored by the Town of Tinmouth, Gail manages the TCF checkbooks. Currently, the Community Fund checkbook has \$11,022 and the Continuing Education checkbook has \$6,094. Of the funds in the Community Fund checkbook, \$8,314 is available to spend (the rest is from 2020 grants that are being held over due to Covid restrictions on their being funded).

Cathy said that the TCF usually spends between \$1,000 and \$1,500 on K-12 scholarships; she recommended that this year \$1,500 be allocated.

Lisa suggested that the deadline for K-12 grant requests be extended because the continuing pandemic has meant that some summer camps and programs may not know if they will be open until the very last minute.

Jan reported that there were nine proposals for 2021 Community Grants, for a total of \$4,500; the proposals had been distributed to the TCF board members in advance of the meeting.

The 2021 Community Grant proposals are:

- Tinmouth Elves
- Tinmouth Directory Committee
- Old Creamery Committee
- Tales of Tinmouth
- Tinmouth Pond Milfoil Project
- Be Seen in Tinmouth
- Tinmouth Mountain School
- Tinmouth Plant Sale
- Tinmouth Walking Club

Members voted to approve all grants.

Jan reported that there were two applications for Small Business Grants, for a total of \$800; these had also been distributed prior to the meeting. Members voted to fund both proposals. During discussion, Melody spoke about receiving a Small Business Grant last year, and how much she appreciated the opportunity it provided.

Cathy suggested that the TCF could do a second round of grants because of sufficient funds to allow this. She invited Melody to write a piece for Front Porch Forum about the Small Business Grants, to encourage more people to apply. Members voted to offer a second round of grant applications.

Regarding K-12 Scholarships, Melody and Asha recommended allocating \$1500, and that the TCF accept applications until the funds are used up. Awards will begin to be made on April 1.

Members voted to allocate up to \$15,000 for Continuing Education grants, \$1,500 for the K-12 Scholarships, and, for Community Grants and Small

Business Grants combined, \$5,300 be allocated for "round 1" (those already agreed upon earlier), and up to \$5,000 for "round 2." Jan seconded the motion.

There was discussion about possibly raising the caps on grants next year. Also discussion regarding summer camps – if a camp is cancelled due to Covid, other activities could be substituted and funded with the original scholarship, at the discretion of the subcommittee.

Jan discussed planning for the annual meeting. Asha offered to host the Zoom meeting; she will create the link and send it to Jan. The agenda will include the minutes from today's meeting, the treasurer's report (Cathy) including the capital campaign, and elections.

Regarding elections: Jan, Todd and Nikki all have their terms ending this year; all agreed to continue on the TCF board. Helen is OK with continuing as secretary, Jan with continuing as president (although she suggested that someone younger should consider taking over next year), Cathy with continuing as treasurer, and Melody with continuing as vice president.

Todd was thanked for updating the TCF page on the town website and doing some much-needed housekeeping of the site.

Members volunteered for various duties for the annual meeting.

The TCF annual meeting will be advertised on Front Porch Forum and on the TCF webpage and town calendar.

Cathy reminded the board that we will need to re-form the Continuing Education scholarship committee at the annual meeting.

Cathy and Todd will discuss what may be needed for web upgrades such as fillable forms. Todd asked if the TCF should have two rounds of funding every year, or one round with increased caps on grants. Jan suggested tabling this discussion until the June meeting to see what proposals come in for "round 2" funding.

Tinmouth Community Fund Annual Meeting 2/27/21

Present were Board members Jan Krantz (Chair), Cathy Reynolds (Treasurer), Melody Squier (Vice Chair), Nikki Pfeiffer, Asha Carroll, Casey Voigtlaender, Todd Dennis, Lisa Patry, and Helen Mango (Secretary), as well as several interested residents of the Town of Tinmouth.

Jan gave a brief introduction with a bit of the history of the Tinmouth Community Fund. The TCF is now in its 22^{nd} year. It began with the construction of the Community Center – with all the volunteer labor and donations made at the time, there was a surplus of about \$85,000 that was used as seed money to begin the TCF. The money was (and continues to be) invested in the Vermont Community Fund. The mission of the TCF is to provide funding for programs and services for the benefit of Tinmouth residents now and into the future. All donations are tax-deductible.

There were originally two funds: The Endowed Fund represented 75% of the TCF and the Reserve Fund represented 25%. The Continuing Education Fund was created 1.5 years ago; it is a separate fund devoted to supporting post-secondary education and training.

Funds are disbursed as: Community Grants, Small Business Grants (for start-up and expansion funding of small businesses that benefit Tinmouth) and K-12 Scholarship Grants (for K-12 children seeking funding for extracurricular programs such as summer camps and sporting activities).

<u>Treasurer's report</u>:

Cathy reported that as of 12/31/20:

Endowed Fund: \$143,379
Reserve Fund: \$59,633
Continuing Education Fund: \$310,559

\$513,571 is at the Vermont Community Fund. The rest is in the checkbooks managed by Town Treasurer Gail Fallar (the TCF is part of the Town of Tinmouth, so the checkbooks are managed by the Town Treasurer).

The Community Fund checkbook contained \$11,022 as of 12/31/20 (this includes \$3300 encumbered by 2020 Community Grants that went unfunded due to the Covid pandemic). The Scholarship Fund checkbook contained \$6,094 as of 12/31/20.

Total net assets of the TCF as of 12/31/20 totaled \$527,116.

The capital campaign for the Continuing Education Fund was launched one year ago, and immediately ran into the pandemic. However, the campaign netted \$99,925; anonymous donations included one for \$52,000 made in May, 2020. For 2021, the TCF has allocated up to \$15,000 for Continuing Education grants.

Review of 2020 Community Grants

Asha listed the Community Grants awards from 2020, and re-iterated that several were unable to use their grants due

to Covid restrictions; those grants have been rolled over into 2021 in anticipation of the easing of restrictions.

2021 Small Business Grants

Melody announced that two local business were awarded Small Business Grants:

- Tom Jewelry (\$300)
- Vermont Mountain Meadows Farm (\$500)

Jan announced that for the first time, the TCF will be able to offer a second round of Community and Small Business grants. The process for applying will be the same as for the first round. Applications will be accepted now until the May 1 deadline.

Todd reported that he has updated the TCF pages on the Tinmouth Town website; applications can now be filled out online, and can be edited until the grant proposal deadlines. The TCF will be notified when applications come in, and applicants will receive a receipt that their application has been submitted. All information and instructions are available on the TCF pages of the town's website. The TCF can be contacted at tinmouthcommunityfund@gmail.com.

2021 Continuing Education Scholarships

Cathy reported that last year's celebration of grant awardees was conducted over Zoom, which had the benefit of allowing recipients in far-flung places to attend the ceremony. All 2020 recipients were able to attend the ceremony. In 2021, the TCF will award up to \$15,000 for Continuing Education grants, which is more than in any past year. All post-secondary training and educational plans qualify. The Town Report (p. 27) contains the list of 2020's awardees.

In 2020, the Johnson Family, Susan McIntosh Lloyd and Pam Garceau memorial scholarships (which are not affiliated with the TCF) were included in the awards ceremony. In 2021 the Lloyd and Garceau scholarships will be included.

Cathy asked for volunteers to serve on the Continuing Education scholarship committee. She explained that a detailed scoring matrix has been developed to help committee members with their decision-making. The committee, which has 10-11 members, only meets once a year (usually at the end of May, for awards in June). Cathy commented on how interesting it is to read the applications and get a glimpse into the lives of these students.

Jan expressed appreciation to Cathy for her many years of work developing and promoting the Continuing Education fund.

K-12 Scholarships

Melody reported that Covid affected the 2020 awards; four grants were given out (totaling \$814), but only two (\$274) could be used, and one had to change its focus to reflect what was actually available. She noted that the K-12 scholarships are not only for summer camps, but can be used for any extracurricular activities that benefit Tinmouth children.

The due date for 2021 K-12 scholarship applications is April 1, but this may be extended as continuing pandemic-related uncertainties persist.

Board member elections: The terms of Jan, Todd and Nikki are about to expire. All have agreed to stand for reelection. Jan asked if anyone else was interested in running for a spot on the TCF board. There were no further nominations. All were duly elected.

Melody proposed setting the K-12 scholarship deadline at May 1, although applications will be considered before then. Awards are made until the allocated funds are used up or the deadline is reached. Members decided the deadline of May 1.

Cathy re-iterated that there will be a second round of Community Grant funding. While new proposals will be prioritized, organizations that received Round 1 funding may apply for Round 2 funding.

Doug Fontein expressed thanks to the TCF, and reported that founding member Ramsey Yoder is currently at Dartmouth Hitchcock Medical Center, and

asked that people keep Ramsey in their thoughts and prayers.

The TCF Board met briefly to nominate board positions: Jan agreed to continue as board Chair, Cathy agreed to continue as board Treasurer, Helen agreed to continue as Secretary, and Casey volunteered to become the new board Vice Chair.

"Red 75" By Tami Carboni

As a farmer, you're forced to face the reality of death more than the average person. My good farmer friend Doug always said, " you got livestock, you got dead stock". Yup, a bit harsh, and I'd just shake my head when he and Leo would laugh at me. Harsh, absolutely...but a life lesson. Your animals are going to die...and yes, it hurts every time. What a farmer has invested in each animal is immeasurable. Most of us have raised each animal since its birth, or close to it, and spend every day for years with it. Leo knew every cow by their udder...not surprising of course, he spent hours in the milk parlor with them. I know them by their facial markings, or, how much trouble they'd get into...yes, there are trouble makers in the cow kingdom.

This was ""Red 75". You can see she's an old girl. I found her dead this past fall. Not a clue what happened to her. Sometimes they actually do just lie down and die. There was no struggle in the dirt that I could see, no injury, just dead.

I didn't know much about Red 75. After Leo died, I had three cows that I couldn't find any information on. It was probably scribbled on a small piece of note paper, or maybe just in Leo's head. It was obvious the three of them were cows and not heifers, (which means they've had a calf before), but that's it.

After the three of them couldn't get bred for a few seasons, everyone advised me to ship them. Nah....I had enough feed, and they were easy enough to handle, so they would stay.

Like every other social group, the personalities are obviously separated. You have the troublemakers, the mean girls, the class clowns, the popular girls, the girly girls, (these cows do NOT like to be dirty!), the drifters, the peacemakers, and of course the "Ferris Bueller" of the bunch...

As I said, I had nothing about "Red 75". If Leo kept her, regardless of whether or not she could get bred again, there was something special about her...And the other cows let me know how special she actually was, the few days after she died.

I could have buried her, which would have been fine, but Leo and I were true believers in "full circle". I called a friend of mine who trains police dogs and feeds a raw diet. He would come get 'Red 75'. Perhaps distasteful to some, but she had a purpose, even after her death...full circle.


I helped load her in his truck, and the rest of the cows surrounded my tractor. My heifers are pretty nosy, so I

didn't think anything of it. We removed her from the paddock, and I chugged off to get some bales for the girls. When I got back, no-one greeted me at the gate like they usually do. Weird, but ok. I put the first bale in the hay rack, and went to get a 2nd bale. A "candy bale" ... a sweet 2nd cutting that quite frankly, I'd eat in a salad it smells so good. I drove in and again no greeting. As I drove further into the pasture, I could actually feel the thick air of grief. Sounds stupid, until you feel it. These girls were mourning. Some separated themselves in the woods, a few huddled together in small groups, some just standing alone. Red 75 was the 'Ferris Bueller' of the group, and they were all missing her. They staved like that for a whole day. It is possible for 20 animals to move around and not hear them. They quietly whispered around. I personally have never seen that before with cows. Horses, yes...not cows.

I knew the old girl was special, even if she wasn't contributing to a bulk tank, or a breeding program anymore, and I'm glad she stayed. I think she had a silent but respected position in the herd, and it kept order. No one has stepped up since, so they're still a bit disorganized, but I suspect another unbred, grey haired lady will fill the position eventually....

As respected as Red 75? Probably not...

RIP old girl...your life was full of value, even though most would say you were "just a cow"...but we know better than that.... ♥


